REMINDER: 2012 DUES

Payment for the 2012 BCGC Annual Membership Dues (\$50) along with renewal of Camp Fickes Shooting Range Annual Access Pass (\$150) is **past due**. Club members who performed approved gatekeeper or workdays in 2011 may deduct \$75 per day credit towards their 2012 range access fee. Please include a note with your payment to indicate the workday activity performed or gatekeeper date(s) done during 2011 in order to back-check club records.

A. Those who purchased a 2011 annual range pass (\$150) and performed two approved workdays in 2011 need pay only their dues (total \$50).

- B. Those who purchased a 2011 annual range pass (\$150) and performed one approved workday in 2011 need to re-pay \$75 toward their annual range access pass along with their dues (total \$125).
- C. Those who purchased a 2011 annual range pass (\$150) and performed no workdays in 2011 need to re-pay \$150 annual range access pass along with their dues (total \$200).
- D. BCGC club members wishing to continue their membership need to pay only their dues. Club members wishing unlimited access to Camp Fickes Shooting Range must purchase an annual range access pass. Or, a club member can purchase daily range access pass at cost of \$15 per day.

- 1. The monthly board meeting was called to order at 6:00 pm.
- 2. A motion was made, seconded and passed to accept the March Newsletter and minutes as published.

A motion was made to dispense with reading of the minutes at all future meetings. Motion seconded and passed.

3. MAIL CALL

• Approximately 80 range access & 25 membership cards are in the mail. Some were distributed at the meeting today. Payments are being received. The Gate combo changing was proposed for April 29th. The proposal was accepted by those present.

4. TREASURER'S REPORT

- Sam Morris said he has replaced our Clubs bookkeeper with a bookkeeper residing in Bailey. The original bookkeeper did not live in Colorado and has not come to Colorado to meet with Sam.
- Sam will meet with the new bookkeeper on Monday April 23rd
- Due to having a new bookkeeper the financial statements for 2011 were not done. They are expected for the May 15th board meeting.
- All BCGC accounts are current with no outstanding bills.
- A motion was made, seconded and passed to accept the Treasurer's report as presented.

5. <u>MEMBERSHIP REPORT</u>

- Prospective members Ty Hagerman, Amanda Miller, Ken Haxby and Jared Heiden talked about their interest in the club and their experience with firearms.
- A motion was made, seconded and passed to accept Ty Hagerman, Amanda Miller, Ken Haxby and Jared Heiden as new members.
- Dan is in the process of getting new membership & range access cards done. We will keep old access codes until April 29th.
- A motion was made, seconded and passed to accept the Membership report as presented.

6. **NEWSLETTER REPORT**

- 130 electronic and 9 paper March newsletters were sent out. 23 not receiving the newsletter. Jack will work with Dan to compare his member address info.
- A motion was made, seconded and passed to accept the Newsletter report as presented

7. ARMORER'S REPORT

- Sam Morris said the clubs rifles from the safe need to have identification done. He has become taking pictures and imprints of the gun serial numbers.
- A motion was made, seconded and passed to accept the Armorer's report as presented.

8. <u>CLINIC REPORT</u>

- Pete said registrations are coming in.
- All CMP events are approved.
- Greg Hawke is following up on NRA matches.
- 13 people are signed up for the Pistol Match this weekend.
- A motion was made, seconded and passed to accept the Clinic report as presented.

9. HIGH POWER REPORT

• Greg Hawke was not present. No report.

10. JUNIORS REPORT

- Mike Brazell, the Junior Executive, discussed his plans for the Juniors. He will put ads in the local paper advertising a special meeting for the public in Bailey. The intent is to determine the level of interest. A discussion took place about the possibility of using the 600 yard range one night a week for the Juniors to shoot. Wed, after 5 pm was suggested by Mike. More discussion is needed before a decision can be made. Mike also asked if the Club would provide 22's for the shooters. It was decided the Club needed to know more before making a decision. Mike said he will need helpers to work with the kids. The members expressed the need to obtain some proper training to be able to help out. Mike will look into what kind of paperwork is needed to satisfy legal requirements.
- Dan has the latest list from Mike Walton of people who have 22's. Gavin recommended we get all of the rifles back, record the info then decide what to do with them. Dan will contact these people & work on getting the rifles back. He will update the Club at the June board meeting.
- Pete was asked to check with CMP if they loan or sell rifles to Clubs with Jr programs.
- It was noted that all AR's are now in the Club possession.
- A motion was made, seconded and passed to accept the Juniors report as presented.

11. RANGE OFFICER'S REPORT

- Jerry Fischer, Assistant Range Officer, has documented to the Board what he has done about putting supplies in the Large Target shed. He will be working on the Small Target shed supplies for Club members..
- Jerry reminded everyone that we are very low on the large plastic backers.
- Jerry said he put one 4 x 6' backer board and will check on how it held up in the next week or so.
- Jerry was given permission to pursue the purchase of 4 x 6' backers.
- Jerry said there is a lot of work that needs to be done, especially at the long range.
- Since there is so much damage being done at the Long Range, he suggested some type of training be offered or made mandatory for all shooters. This was also brought up in last month's meeting. Discussion but no assignment resulted.
- It was noted that the Camp Fickes website has a list of what the public should bring to the range.
- A motion was made, seconded and passed to accept the Range Officer's report as presented.

12. OLD BUSINESS

- Gavin said there is no change to last month's status on the construction of a roof over the short range firing lines.
- Date for the Open House in August was not discussed.

13. ASSIGNMENTS

- **Sam Morris:** The issuance of stock certificates still needs to be done. Gavin will follow up with Brian, our Lawyer.
- **Sam Morris:** Still needs to obtain a document from our Lawyer regarding the Club's guns. Sam has again called & left messages with Brian to contact him.

- Sam Morris: Sam will meet April 23rd with the new bookkeeper he hired for the Club. He plans to bring our 2011 yearend financial statements to the May 15th board meeting.
 <u>Update</u>: Sam met with the new bookkeeper and they are at least 1/3 done. They will try and finish when they meet on the 30^{th.}
- **Dabney**: The Liability Form has been reviewed by the BOD & our club's lawyer, Brian. Dabney has the version that is OK to be used by the Gate Keepers.
- **Dabney**: Dabney is working on the antenna and will talk to Jerry.
- **Gavin**: Gavin has not heard back from his Bureau of Prisons contact (Mark) regarding their doing work on the Ranges for us. Will continue to pursue this.
- **Gavin**: Gavin has submitted (online) the paperwork to get a road permit. (Sam said the current one expires 12/31/12)
- **Dean**: Dean purchased tree permits for \$ 60 to remove 3 cords of wood. These expire on April 30th Dean said it would take 3 people 2 days to do the tree removal and may need to close some of the long range. He & Dabney will work out a schedule.
- The small gun safe has not been moved
- John: is checking into the possibility of purchasing 223 ammo in bulk for the clinics

14. NEW BUSINESS

- Gavin said that the Revolutionary War Veterans Association's Project Appleseed program was very well received by those present on the weekend of April 14/15
- On April 15th the range had 10" of new snow but the Appleseed program continued as planned.
- No contact made yet by with the Forest Service about opening up areas along the road to get more sunlight in to eliminate current road problems.
