Prior Months Meeting Minutes – No meeting took place in March due to the Covid Closure.

Motion to accept by Brian Hunter; Seconded by Jim Madere. Passed unanimously.

Membership Report (Deland Barr) – 274 members; 4 New for 2020. Holding cards for 32 members.

BCGC AGENDA TOPICS -

OLD BUSINESS – Owen Maddox

- Still not sure when the Conex's will be moved to the range, depends on road conditions and range closure – Owen Maddox
- Update members on Range Closure – Owen Maddox: Range closure does apply to BCGC effective through May 31 for the time being. Ken asked who issued that order, Owen replied Federal Government.
- Possibility of adding two Pistol Bays in the parking area close to the Long Range berm – Deland Barr & Owen Maddox: Deland explained that the parking area could be converted to two additional pistol bays which was previously rejected due to cost but now that the Pistol Bay complex has proven to be too costly he is suggesting we revisit this as a possible option. Owen thinks that a berm will interfere with HP shooters who need to see the impacts in the berm. Owen suggests area between berm and parking area. Some discussion ensued as to whether this would be able to happen in a safe manner. Suggestion was made to draw out proposal so that it would be better understood and firing lines and berms can be determined to be safe.

New Business

- By-Laws are being reviewed for update by Owen Maddox. If you have any recommended changes, please send them to bcgc777@gmail.com
- Due to Covid-19, our tax deadline has been extended until July 15th, 2020 – Owen Maddox
- Investment back into the market – Owen Maddox suggests we study market to see where we can identify investment opportunities. Ken suggested S&P 500 Index fund as an investment. Rob suggested VTI.

Anything from the Members?

Sam asked if we were interested in leasing property to build pistol bays. Response was divided but at least 8 members said yes. Ken brought up concerns about lack of communication and ensuing liability. Gary raised concerns about range closure prior to USFS order to shut down. Owen explained that the 6 board members that met voted unanimously to close the range. Adam suggested those dissatisfied can amend bylaws accordingly. Jim stated that on March 26th, statewide closures were reported and that USFS issued contradictory statements. Rob stated he applauds Board decision to close range using info they had at time. Mike Spratt stated he was involved in decision and feels it was right based on available information and liability reasons. Ken asked since range is located in Jeffco, who the representative is, Joe Neguse?
