### Old Business:

- (BH) We added an additional \$ amount to the Short Range Shed project.
  - Not Purchased yet. OM to purchase.
- (BH) Maintenance to Range Vehicles
  - Put call to Membership to help with maintenance.
  - GZ gathered vehicle spec for eventual purchase of filters, etc. Member Daryl Eng identified to perform maintenance on vehicles and fire systems.
  - Expected contribution is 2 works days.
- (BH) Disbanding Committees:
  - Target Acquisition – Complete, spent moneys from NRA grant 2020. – Disbanded.
- (BH) By-Laws still working changes
  - Worked with Legal Team and BoD to complete
  - (OM) to distribute to Membership and vote shortly
- (BH) Long Range Barricade for PSR
  - Tank Traps are on 200 yrd range
  - 2 more Barricade being built.
- (JH) Strategic IT Plan
  - Plan is progressing – expected draft to BoD for review May
  - Objective is for BCGC to act more like a business from an IT perspective
- (GZ) Forest Service Tree Identification along Road
  - FS walked road with BoD to mark trees for removal, ~185 trees potential
  - No timeline for removal yet.

### New Business:

- (BH) Scout Troop Request: Dabney sent email – Can a scout troop use short range on May 7, 2022. Same troop as last year.
  - Merit Badge Need.
  - Take up 5 lanes – most of the day.
  - Request a Work Day in return for access those lanes.
  - GZ to contact Dabney and move request forward.
  - **(SE) Motion: To have the Scout Troop use 5 lanes May 7<sup>th</sup> for the day for no charge. (JW) 2<sup>nd</sup> - Approved**
- (JH) Steel Target posts on Long Range:
  - Saturday Apr 16<sup>th</sup> (Brad Oswald, George Schmidt (GS), John Harms (JH) & Eric Brody) installed 10 long range PRS steel target posts on the IDPA Berms. Approved by board during March BoD Meeting.
  - There is a question of those posts need some sort of protection (Prevent Impact and Ricochet).
  - Objective is to minimize Consumables (2x4's, etc.) and protect current posts with deflection protection and identify them with BCGC logo.
    - Angle AR500 Posts are \$81/ea.
    - The plan is to place, AR500 shields on the posts for \$51/ea. Are removable/replicable and Cheaper.
  - Further assessment for post access/protection to be considered by PSR group.
  - Need for a more permanent replaceable solution – Steel Pipe/Cemented with Posts replaceable between shooting.
- (GZ) Work Day – May 19<sup>th</sup>/20<sup>th</sup>?:
  - Long Range Marker 7 down – Needs Replacement
  - Replace short range target holders
  - Lead Mitigation
  - Stat house porch repair
  - Etc.

- Need 10 People to complete work, best if 2 work days
- Looking at Calendar 14<sup>th</sup>/15<sup>th</sup> free.
- No determination for Work Day, GZ to review calendar and pick a day.
