BUFFALO CREEK GUN CLUB MEETING MINUTES September 15, 2009

1. The monthly board meeting was called to order at 7:10pm.
2. **MAIL CALL**
 - Received: 1st Bank deposits; American Hunter; Whittington Center; CSSA membership.
3. **TREASURER'S REPORT**
 - No report. (Sam Morris arrived late: "The finances are in order.")
4. **MEMBERSHIP REPORT**
 - A motion was made, seconded and passed to accept Lawrence Layman as a new member.
 - A motion was made, seconded and passed to accept the Membership report as presented.
5. **NEWSLETTER REPORT**
 - No report.
6. **ARMORER'S REPORT**
 - Ron Porter checked out a club rifle for a smallbore junior.
 - River Valley Ordinance still hasn't returned the club's brass.
 - Kent Beach reports that some rifle cleaning remains to be done.
 - A motion was made, seconded and passed to accept the Armorer's report as presented.
7. **CLINIC REPORT**
 - The board set new prices for next year's clinics: Single clinics: adults \$65, juniors \$55. All four clinics: \$200 for adults and juniors.
 - The board discussed the possibility of staging additional special clinics; if such were held there would be a \$50 fee (\$25 for ammunition and \$25 rifle rent).
 - A motion was made, seconded and passed to accept the Clinic report as presented.
8. **HIGH POWER REPORT**
 - The board set new prices for next year's July championship matches: Wednesday: Advanced Clinic \$15 (pre-registration required); Thursday: Squadded Practice \$15; Friday and Saturday: Championship Matches \$45 each (no discounts for women, juniors or seniors); Sunday: \$10 range fee (non-members only), plus Team Match fee, plus Leg Match fee.
 - Beginning next year, all match directors will be required to turn in—along with match receipts—the top section of the SR registration form for each competitor, listing the match fee paid by each.
 - Next year's Monthly Match fee will be \$10 range access fee (non-members only), plus \$15 match fee—that is \$25 for non-members and \$15 for members.
 - At the July Championships all competitors will be required to show proof of CSSA membership or membership in their home state's association, or else purchase a temporary CSSA membership. Arizona and Texas shooters will be charged for the temporary membership because those states charge a similar fee to Colorado shooters.
 - A motion was made, seconded and passed to accept the High Power report as presented.
9. **JUNIORS REPORT**
 - No report.
10. **SMALLBORE REPORT**
 - The league starts up by the end of the month with 20 record weeks and several practice weeks scheduled. Shooting will be conducted at Cherry Creek Gun Club and Boulder Rifle Club.
 - Earl Perry (303-233-3110) is getting together a .22 ammunition order for the league.
 - A motion was made, seconded and passed to accept the Smallbore report as presented.
11. **RANGE OFFICER'S REPORT**

- Dan Gabel has ordered 40,000 target pasters from Gil Hebard.
 - A motion was made, seconded and passed to accept the Range Officer's report as presented.
12. **OLD BUSINESS**
- The board discussed club finances and made plans for a report to the membership, which will also include a full explanation of the functioning structure of the club's organization and operations.
 - **NOTE:** The December Newsletter will contain a full financial report for BCGC and Camp Fickes Shooting Range.
13. **NEW BUSINESS**
- Kent Beach reports hearing from George Yeagle that Ray Barrett's health is improving. Ray has been moved to the VA hospital at Walsenberg.

A motion was made and passed to adjourn at 9:16pm.
