PRESIDENT'S CORNER

Thanks to all the members and guests who attended the August Board of Directors (BOD) Meeting.

BCGC Permit for Operating your Club within the Pike National Forest

I want to thank all of you for your tremendous support through this long and arduous ordeal. It has been difficult for you and your Board of Directors. After working on this issue for over 16 months, we finally came to an acceptable agreement with the US Forest Service (F/S). The Permit is now being finalized by the F/S headquarters in Pueblo. I hope to hear soon that they are ready to issue a 20-year Permit.

The details of the Permit negotiations are summarized below:

- 1. The Club Permit was to expire on December 31st, 2016.
- 2. We began working the renewal issue in the spring of 2016.
- 3. At that time, we were informed that a Reclamation Bond would be required prior to the renewal, in the amount of \$100,000, as determined by the F/S engineers.
- 4. We negotiated the amount down to \$50,000 by volunteering to accomplish a "lead mitigation program" twice each year and provide the results formally to the F/S.
- 5. Sixteen banks and insurance companies were contacted, with the result being denial for the Reclamation Bond, from all of them.
- 6. Since your Club could not afford to post a Cash Bond for 20 years, we proposed an alternate solution we would place \$25,000 in a bank Certificate of Deposit and provide the F/S with a "Letter of Credit" from the bank. We would contribute an additional \$2,500 annually for ten years to satisfy the \$50,000 Reclamation Bond requirement.
- 7. Our proposal was verbally approved on August 14th, 2017.
- 8. The Permit must be finalized by the F/S and signed by both parties. The "Letter of Credit" must be obtained by your Club and provided to the F/S. After that is complete, we will start working on a renewal Permit --- 19 years from now.

Thank you again to all the dedicated members who made donations, offered loans for the Bond, contacted your Insurance Companies and many other forms of support. We could not have completed this issue without your assistance.

I hope to see many of you at the next BOD Meeting at 6:30 PM, on September 19th, 2017 at the Indian Hills Community Center.
