The meeting was called to order at 6:30 PM

### **OLD BUSINESS - (6:50)** – Owen Maddox

- **“Committee Chair – Dean Barr**
  - Rewrite SOP – still working on it.
- **Owen -- Met with Forest Service to discuss the new range proposal-**
  - Bad news, USFS executive committee turned down our local district office’s 2019 budget request to do survey for new proposed pistol range. Owen will continue to push for approval and or offer additional suggestions.
  - Fire Restrictions – Lowered to Stage I Conditions. Range open again.
  - The Club’s reaction:
    - Fire Extinguishers on location
    - Shovels on location
    - Two Fire Fighting Systems – In place soon
    - Publish Emergency Procedures – Coming soon
    - Train Members on Equipment & Procedures – Already started
    - Trained 22 members on proper use of Fire Extinguishers
    - Video will be placed on website for all other members to review
    - Newsletter will be dedicated to covering fire safety.

## **NEW BUSINESS - (7:10)**

- Brian – inter-club correspondence – Member Planet can be used to communicate with other members. Any member can go to member planet, locate the member, and click on the email icon to send them an email without disclosing their own email address. Members who have not yet joined Member Planet are encouraged to sign up and make use of all the features it provides.
- Owen – All members should enforce Range Safety Rules when they witness an infraction. Doing a good job on the whole but we must remain vigilant, especially with the fire restrictions in place. Report any members not following the rules.
- Jim said he had a woman contact him with questions about the range. She was from Groupon wanting to promote the range to public shooters. Range is not suitable for a Groupon promotion.

### **Anything from the Members?**

Frank McKeon stated members and/or Gate Keepers can call 911 if they are in a dispute with a public shooter or another member, if the situation warrants. They would have to leave the range property to obtain cell service. This info is a part of the Gatekeeper SOP. Frank also mentioned that some Gate Keepers are not emptying the trash containers, especially the one by the Stat House.

Lech Gacek mentioned that he has noticed Gate keepers not performing Range Officer duties by monitoring firing line activity, when they are not occupied with registering shooters.

Jim Madere asked if we should authorize Owen to spend some amount of funds on the Survey that USFS did not authorize? Brian Hunter mentioned that he thought that club already gave authorization when members approved pursuing the Pistol Range Project. Owen wanted to hold off until he has had further discussions with USFS.
