BUFFALO CREEK GUN CLUB MEETING MINUTES December 9, 2003

1. The meeting was called to order at 7:22PM.
2. A motion was made, seconded and passed to approve the November minutes as presented in the Newsletter.
3. **TREASURER'S REPORT**
 - The club's checking account balance is \$21,001.16.
 - The State of Colorado paid the club \$180 for use of the range.
 - The club paid the Forest Service a fee of \$127.97 for the road into the range.
 - The club is due to receive \$652.06 from our previous insurer, which has gone into receivership. The Insurance Company of Hanover now insures the club.
 - A motion was made, seconded and passed to accept the Treasurer's report as presented.
4. **MEMBERSHIP REPORT**
 - A motion was made, seconded and passed to accept Jerry Fischer as a new member.
 - A motion was made, seconded and passed to accept the Membership report as presented.
5. **NEWSLETTER REPORT**
 - 198 newsletters were sent out; none returned.
 - A motion was made, seconded and passed to accept the Newsletter report as presented.
6. **ARMORER'S REPORT**
 - Kent Beach has examined a large safe, which is for sale at \$900. He reports that it will hold all of the club's AR's with room left for storing valuable club documents.
 - A motion was made, seconded and passed to approve purchase of the safe and to cover the installation expenses.
 - No recent contacts have been made with the CMP.
 - A motion was made, seconded and passed to accept the Armorer's report as presented.
7. **CLINIC REPORT**
 - No report
8. **SILHOUETTE REPORT**
 - The September match drew a very light turnout. David Bonner won both standard and hunter rifle matches.
 - In October Bob McAlice won both the standard and hunter rifle matches.
 - A motion was made, seconded and passed to accept the Silhouette report as presented.
9. **HIGH POWER REPORT**
 - Match fliers and lists are completed; they will be mailed in January.
 - The club's 2004 matches have been registered with the NRA.
 - A motion was made, seconded and passed to accept the High Power report as presented.
10. **JUNIOR REPORT**
 - No report

11. **RANGE OFFICER'S REPORT**

- Dan Gabel requested names of all those who volunteered to help or coach for matches and clinics so he can assign work-bond credit.
- Darrell Evig has installed a spark arrestor in the stat. house chimney.
- The Bailey Challenge had to be postponed for a week due to a snowstorm; this reduced participation to just 9 adults and 1 junior. Total expenses for the match (food, prizes and advertising) came to \$293.48. Participants paid \$104 in match fees.
- Following the recent newsletter report of repairs to the target house roof, the person handling permits at the Forest Service admonished club representatives to clear all improvements to the range with the Forest Service prior to implementing them.
- A motion was made, seconded and passed to accept the Range Officer's report.

12. **SMALLBORE REPORT**

- Mike Walton provided the board with an updated list of all smallbore target rifles held by the club along with records of those persons to whom the rifles have been loaned.
- A motion was made, seconded and passed to accept the Smallbore report as presented.

13. **OLD BUSINESS**

- The 1943 Denver Post article about "Camp Buffalo" has still not been located.
- Dabney Crump explained reasons for moving the annual dinner/meeting to Le Peeps at Quebec and County Line Road. The club will have use of the entire restaurant, the menu is both attractive and the price lower, and the service should be better. The annual dinner/meeting is scheduled for Saturday, January 10th.

14. **NEW BUSINESS**

- Jon Coppenbarger has acquired a significant quantity of 20 round AR magazines; those interested should contact him for a good deal.
- In a recent meeting with Forest Service officials, club officers were informed that the land leased by the club has been valued at \$1800 per acre. The annual lease fee (at 7% of value) would thus become \$5963.58. Club officials were told there is no appeal to this fee increase or the process by which it was determined.
- The board discussed, in considerable depth, issues related to the information received from the Forest Service.
- Mike Bevelhimer will request another meeting with Forest Service officials at the earliest date possible.
- The board discussed the possibility of raising annual dues; the matter was tabled for further discussion by the membership at large during the annual dinner meeting.

A motion was made and passed to adjourn at 8:43pm.
