 - The need of being a NRA member to join the club was discussed. Some members thought this was an unnecessary requirement. After a lengthy discussion, the BOD decided this would remain a requirement of becoming a BCGC club member.
 - A motion was made, seconded and passed to accept the Membership report as presented.

 - 4 of the club's rifles remain to be cleaned.
 - The club Armorer will choose the rifle for the raffle prize.

 - will be asked to leave the range and not allowed back.
- There is someone who continues to blow the targets and target stands to pieces. This results in damaged target stands and litters the range with little plastic bits. If you see someone damaging club property please contact one of the club officers.
