501(c)(7) to 501(c)(3) – Owen Maddox – The Club has been working with a CPA to change our tax status to a 501(c)(3) to allow us to accept Tax Free donation from the public & members. CPA wants to know about proceeding with the Plan this month. Camp Fickes Shooting Range,

Inc. will dissolve and re-appear as Camp Fickes Shooting Range, LLC. Deland Barr made a motion to continue the Tax Status change for both organizations; Jim Madere seconded the motion. The motion passed unanimously. Owen will talk to the CPA & lawyer about completing the paperwork to send to the IRS.

- Jim Starr Memorial Stone Owen working on completing. Stone ordered & should be complete in March 2016.
- New Pistol Bays Owen Maddox Met with Forest Service to get environmental study going and talk about moving Colorado Trail to allow safe expansion of Pistol Bays. USFS now agrees with the location we originally wanted.
- The BCGC Annual Membership Meeting/Banquet will be held at the VFW Hall in Golden January 16th, 2016. It starts at 6:00 PM. Payment will be automated through Member Planet for the Banquet, Range Access Fees & Membership Dues. Maximum seating of 150. Donations wanted.

- Concerning the issue of Amending the Bylaws of BCGC to conform to IRS Statutes for the
 purpose of converting to 501(c)(3) status, there were 95 members present for the vote, either
 personally or by Proxy; all were confirmed to be Members-in-Good-Standing by the Secretary
 and Membership Chairman. 61 members were required to be present or send their Proxy; of the
 95 members present, 64 votes were required to vote Affirmative for the measure to pass; all 95
 votes were Affirmative, so the BCGC Bylaws will be amended.
- Deland Barr made a motion for a vote of confidence for Owen Maddox concerning the 501(c)(3) issue; Dabney Crump seconded. The motion passed unanimously.

The meeting adjourned at 7:38 PM.
