 - The bullet order is in process with delivery scheduled in three weeks.
 - The barrel order is on hold. Two more barrel orders are needed to get the discount.
 - The spindle project is ongoing.
 - The 1998 Clinic Schedule was approved. Several suggestions on how to improve the clinics were discussed.
 - The A.M.U. will conduct a clinic at BCGC this summer.
 - The 1998 shooting calendar was discussed. A motion was made, seconded and passed to approve the BCGC dates.
 - Preliminary work to obtain approval for the range expansion is continuing.
 - The tabled bullet fund program was withdrawn.

9. **NEW BUSINESS**

- The draft of the Hold-Harmless-Agreement was discussed. Once completed it will need to be signed by everyone over 18 each time they use the range.
- It was confirmed that the BCGC Board position of Cowboy Executive Officer is an elected position.
- George Kruger volunteered to be the C.M.P. contact person.
- A question was brought up concerning when a rifle is considered "SAFE". **A rifle is considered safe when the open bolt indicator is installed.**
- A motion was made, seconded and passed to offer Mr. Gavend a continuing Associate Membership for services rendered in the past and continuing into the future.
