BUFFALO CREEK GUN CLUB MEETING MINUTES – FEBRUARY 13, 2001

- 1. The meeting was called to order at 7:12 PM.
- 2. A motion was made, seconded and passed to approve the January minutes.
- 3. **TREASURER'S REPORT**
 - The Treasurer's report showed a checking account balance of \$4915.01 and \$12,130.29 in CD's.
 - The Range Fund and Junior Fund still have a zero balance because of the current low General Fund balance.
 - The term of the CD expires on February 25th; it will be renewed unless the board decides otherwise.
 - George Kruger is still in the process of obtaining authorizations for the new treasurer, Richard Bowman.
 - A motion was made, seconded and passed to accept the Treasurer's report as presented.

4. **MEMBERSHIP REPORT**

- Mike Bogard delivered the report using notes from Dan Gabel, who could not attend.
- Dan wants his address included on the new application form so that the completed applications come back to him by return mail.
- The board voted unanimously to accept Tom Philips as a new member.
- A motion was made, seconded and passed to accept the Membership report as presented.

5. **<u>NEWSLETTER REPORT</u>**

- 160 newsletters were printed; 152 were mailed.
- The newsletter sent to former board member Bill Doan was returned. The board has no knowledge of a change in his address.
- A motion was made, seconded and passed to accept the Newsletter report as presented.

6. <u>CMP REPORT</u>

- CMP is apparently moving to sell out its stock of Garands and .30 ball ammo. Any member is now eligible to buy up to 5 rack grade Garands and up to 5000 rounds of ammo; ammo sales are not contingent upon rifle sales.
- The board decided that the club should not purchase additional .30 ball ammo at this time because we have a sufficient supply to conduct M-1 clinics for at least two more years. There is no certainty about how long M-1 sales will continue or how long the club can continue to draw shooters for M-1 clinics.
- The club can now reorder AR-15's again. (See New Business.)
- New training tapes are available from the CMP, but High Power tapes are not yet available.
- New rules are forthcoming from the CMP Competition Board. At least one is likely to address the positioning of the M-16 or AR-15 buttstock on the shoulder
- As predicted. Kimber M 82's are now available, NIB for \$600; Remington 541's are available to clubs for \$225.00.

- M-1 Carbines are available to clubs that sponsors juniors. The board is considering the purchase of additional Kimbers and M-1 Carbines.
- A motion was made, seconded and passed to accept the CMP report as presented.

9. <u>HIGHPOWER REPORT</u>

- New High Power Exec Vince Carroll was welcomed to the board. Jim Starr will coach Vince on his duties through the rest of this season.
- Copies of the Match Sponsor's Packet were distributed to the board.
- Jim Starr announced that match announcements/registration forms would be sent out next month. He and Mike Walton will work on an updated and expanded mailing list.
- A motion was made, seconded and passed to accept the High Power report as presented. <u>JUNIOR REPORT</u>
- Jim Starr is still organizing the Junior team for 2001.
- Jim requested \$600 from the Treasurer to cover start-up costs on a new raffle; the request was approved. Jim needs a current membership list to complete the raffle mailing.
- Mike Bogard needs documentation for renewing the club's state raffle license.
- This year Juniors going to Camp Perry will be responsible for more of their own expenses, due to less funding. Each will have to pay \$265.38 to cover entry fee and the first night's lodging.
- Letters will soon be sent to prospective members of the Colorado team traveling to Camp Perry, both Juniors and adults.
- A motion was made, seconded and passed to accept the Junior report as presented.

11. RANGE OFFICER'S REPORT

- Mike Bogard delivered the report using notes from Dan Gabel, who could not attend.
- Target pasters still need to be ordered.
- A work party at Dan Gabel's house for target construction will be organized soon.
- Spring Workdays are scheduled for April 28th and 29th, with May 5th and 6th as back-up dates.
- A new lock needs to be purchased for the small target house.
- A new combination for the main gate lock will be set on or before the Spring Workday.
- The manufacturer of the skylight used in the target house is now out of business. Dan will consider other sources to replace the damaged skylight.
- A sample target pulley assembly prepared by Dan was shown to the board; it was approved for testing.
- A motion was made, seconded and passed to accept the Range Officer's report as presented.

12. **SMALLBORE REPORT**

- No report.
- 13. OLD BUSINESS
 - Dabney Crump presented the board information from Marie Calender's restaurant; it may be a better site for next year's annual meeting. Jim Starr will locate information on other restaurants used by the club in the past.
 - A motion was made, seconded and passed to thank Mike Bevelhimer for the \$740 he "donated" to the club as a result of his own math error when calculating the cost to

members of CMP AR-15's purchased last year; the board voted to repay him next month.

- Jim Starr asked the Membership Exec. to be sure that out-of-state life members receive new membership cards and gate numbers each year. He mentioned Mid Tompkins in particular. He also asked that those with honorary memberships receive the same service, and he mentioned Pete Blanc in particular. The board agreed that a separate list of life and honorary members should be kept to facilitate this process.
- Correction to the notice in last month's newsletter: the club only needs one permanent copy from each member of the Release of Liability form; it does not have to be resubmitted each year.
- Mike Bevelhimer and Mike Walton reported on sources and costs for .223 ammo to be used in a trial-run AR-15 clinic this summer.

14. **NEW BUSINESS**

- A motion was made, seconded and passed to purchase 8 new Bushmaster AR-15's from the CMP. Seven will be sold to members for \$1010.00 each, and one will be donated to the Juniors. At present, 4 of the 7 rifles are already spoken for; members who are interested in the purchase should contact Mike Bevelhimer SOON.
- A motion was made, seconded and passed to establish a date and a format for an AR-15 clinic this season.
- Mike Walton reported to the board on the creation of a new annual High Power awards program to be run through the CSSA. The traveling trophy, a bronze ram mounted on a large pedestal, has been named in memory of former BCGC member Charles Lavelle who was suddenly taken from our ranks last September in a construction accident. Announcements and registration forms will be sent to competitors next month.
- Kent Beach is preparing a powder purchase and a bullet purchase; members who are interested should contact Kent soon.
- Jim Starr has surplus 4895 for sale at just \$8.00/lb.

The meeting adjourned at 9:14 PM.

ANNOUNCING

The Colorado High Power Trophy Series Featuring The Charles Lavelle Memorial Trophy

A new annual awards program has been instituted to honor the top competitors in Colorado High Power matches. A bronze sculpture of a bighorn ram has been commissioned; it will stand atop a six-faceted trophy pedestal with panels to feature the annual Overall Champion and the five annual champions by classification, High Master, Master, Expert, Sharpshooter, and Marksman. Award presentations will be made at the CSSA's Annual Meeting, and the home club of the reigning Overall Champion will retain the trophy during the year. The trophy has been dedicated to the memory of one of Colorado's most distinguished riflemen, Charles Lavelle, a member of the Olympic Palma team and winner of numerous rifle tournaments and annual shooting awards in Colorado and the region. Charles Lavelle died in September, 2000, at the age of 53.

The annual awards will be based on high aggregate scores, overall and by classification, from four matches. Those who register for the annual awards may compete in as many Colorado High Power matches as they wish; however, only four of their highest scores will be figured in their trophy aggregates. The four high scores will be selected according to the following Program Rules:

(1) The Trophy Aggregate will be comprised of the competitor's highest scores from four NRA or CMP sanctioned three-position matches conducted in Colorado between January

1st and November 30th of the calendar year.

(2) The Trophy Aggregate must include scores from matches sponsored by at least three different Colorado clubs.

(3) At least two of the four matches represented in the Trophy Aggregate must be NRA Registered Championship matches, and at least one of those two must be a full course (600yd.) match.

(4) One and only one of the four matches represented in the Trophy Aggregate must be a 50 shot National Match Course match, either NRA or CMP sanctioned.

(5) The highest possible score for the Trophy Aggregate will be 2900 points, the total possible scores of three 80 shot matches and one 50 shot match.

Eligibility: Any member of the Colorado State Shooting Association who has a NRA High Power classification may register for the annual awards competition. Non-residents may also register if they have the required classification and are members of their home state's shooting association.

Registration: Registration will remain open during the entire term of the competition; no registrations will be accepted after November 30th. Registration forms can be obtained from High Power match directors at most Colorado shooting clubs or directly from the CSSA, 609 W. Littleton Blvd., Littleton, CO 80120, 720-283-1376.
