PRESIDENT'S CORNER

Thanks to all of the members who attended the February BCGC Board of Directors meeting. Several issues were discussed and some big projects were approved by the Board.

The first Motion approved by the Board was to proceed with plans for a new seven-bay Pistol Range & locate it between the current Short Range and the Jim Starr Range. The Motion carried unanimously.

The second Motion approved by the Board was to proceed with the purchase of a used Track Loader (equivalent to a Cat 977L) rather than rent for an extended period. The intent is to use the equipment for all major projects & then sell it. The details in the purchase will require Board approval.

The Conifer/Evergreen Friends of NRA will be Granting your Club \$8,000 to proceed with the renovation of the Long Range Berm Project. They are truly a friend of Buffalo Creek Gun Club. Their annual Banquet is on March 13th at the Memorial Barn in Evergreen. They are also conducting a Raffle for a Daniels Defense DD4 V1. Only 100 tickets will be sold, so your chances of winning are great. The Banquet will have many guns, shooting related items and possibly Big Game hunts to win or bid on. The cost estimate for erecting a Red Flagstone near the 600 yard shooting line in memory of Jim Starr was received. The cost is prohibitive however, an alternative was approved and will be pursued. The alternative will result in a nice Red Flagstone erected near the Jim Starr entrance gate and a Bronze Plaque to be placed on/in the Stat House.

A Life Membership (\$100) in the BCGC Steel Challenge Club is still open to any BCGC member in "Good Standing". Starting next month we will conduct two Matches each month; one on the first Thursday and the second on the third Saturday. Dates for the March Matches are the 5th & 21st. I look forward to seeing many of you at the next Board of Directors meeting on March 17th, 2015 at the Indian Hills Community Center. We will once again, have pizza & drinks after the meeting.
