PRESIDENT'S CORNER

Thanks to all the members and guests who attended the February Board of Directors (BOD) Meeting.

Your support of the Conifer VFW Post 12009 is greatly appreciated. Good luck to you all on winning the Springfield pistol.

We now have a current 5-year Permit for operating our range. We placed \$25,000 in our bank and received a Letter of Credit (LOC) to present to the US Forest Service to meet our financial obligation in lieu of the required "Reclamation Bond". Your club will deposit an additional \$2,500 per year for the next 5 years and at that point we will automatically receive another 5-year Permit. The following 5-year period will be a mirror image of the first 5-year period. At that point, we will have \$50,000 in our account and have another LOC, but this time it will be for \$50,000. When that LOC is presented to the US Forest Service, they will work with their Headquarters to issue a 20-year Permit to BCGC. As long as we meet our operational and financial obligations with the US Forest Service, we can consider our Range operationally viable for the next 30 years.

We now have approximately \$76,000 in donations ear-marked for the proposed 12 Pistol Bay Range Project. We are waiting for the US Forest Service to study the proposal and issue permission.
