- We need to track training statistics because the club attained its non-profit designation as a training organization.
- Also, the training data helps when applying for NRA grants.

High Power (JH)

- Absent. No report.

Motion to accept above reports (OM), 2nd (GZ) – Passed.

Old Business

- (OM) Project to move the gate to the Long Range from its current position back to the Stat House has been approved by the Forest Service.
- (OM) Executive Management Review
 - Goal is to remove inactive positions and duplicate names from the list.
 - This issue was discussed by the BOD.
 - **Motion to remove the identified positions and names (OM), 2nd (JM) – Passed.**
- (OM) How to increase the number of Gate Keeper volunteers
 - This issue was discussed by the BOD.
 - The decision was to have a Gatekeeper training day before May.
 - **Motion to give first time Gatekeepers two tickets in the Gatekeeper firearm drawing at the January meeting, and one ticket for each Gatekeeper day thereafter. (OM), 2nd (SE) – Passed.**
- (OM) Match fees for shooters over 70 years of age
 - This issue was discussed by the BOD.
 - Some matches offer a \$5.00 discount per match for members and non-members over 70. Other matches do not.
 - **Motion to eliminate discounts to members and non-members over 70 for all BCGC matches. (OM), 2nd (GZ) – Passed.**

New Business

- (OM) Buying a table at the Friends of NRA banquet
 - The club has done this for several years.
 - At past banquets, the club has obtained firearms to give away via a drawing at our January meetings.

- This issue was discussed by the BOD.
- **Motion to buy a table at the Friends of NRA banquet. (OM), 2nd (BH) – Passed.**
- (GZ) Range work days schedule
 - OM and GZ will discuss.
- (SE) If requested, should the club refund work bond money to members who move or to the spouses of members who pass away?
 - This issue was discussed by the BOD.
 - Our Bylaws permit us to refund the work bond when someone leaves the club, in good standing, if they request the refund.
- (GZ) Boy Scout use of our range.
 - Troop 317 wants to use the pistol portion of the short range.
 - The Scouts will provide their own firearms, Range Officers, and supervision for the boys.
 - We need to ask them for a copy of their insurance.
 - They will need to sign Release of Liability forms.
 - They asked for May 4th or 5th from 8:00 am to 1 pm.
 - However, there is a Precision Rifle League match on the 5th. Therefore, the long range will be closed on the 5th along with half the short range if the Scouts use the range that day. The 5th does not appear to be a good choice.
 - **Motion to allow the Boy Scouts to use the pistol portion of the Short Range on May 4th. (OM), 2nd (GZ) – Passed.**
- (Eric Brody) presentation asking BCGC to cover costs for the Precision Rifle League (PRL)
 - The PRL matches are now on Practiscore.
 - Under this proposal BCGC would own all the equipment and receive all the funds collected by the matches.
 - Based on growth to date, Eric estimates the PRL will be profitable for the BCGC by 2026.
 - All of the requested funding is not needed at one time.
 - OM noted that JM had to leave early so only five Board members are in attendance. Although this is still a quorum, OM would prefer to discuss this with all Board members via email. So a decision will be postponed until that time.
 - Eric will email the handouts he presented at the meeting to all Board members.
- (SE) when will the members' gate code be changed for 2024?
 - GZ will change the code for the members' gate lock.
 - OM will email the change notification to all members.

Motion to adjourn meeting at 8:48 pm (OM), 2nd (BH) – Passed.
