## **BCGC ANNUAL MEETING MINUTES – January 15, 2011**

The annual dinner meeting was held at the Hickory House, 10335 S Parker Rd, Parker, CO on Saturday January 15, 2011.

- 1. The President of BCGC, Mike Brazell, called the meeting to order at 8:05 P.M.
- 2. The President gave an opening statement in which he:
  - Stated that while there are still a few issues to be worked out, the Buffalo Creek Gun Club is well positioned for the 2011-shooting season.
  - Said that we gained 46 new members in 2010 who learned about the range through the two open houses: the ads in the local newspaper: and the flyers passed out at the gun shows.
  - Discussed the problem of the trash that is being left behind by the public shooters.
  - Gave an overview of the proposed range improvements.
  - Stressed the need for members to volunteer as gatekeepers.
  - In reference to a members question stated that we had excellent relations with the USFS.
  - Asked that members send ideas on a possible new meeting location to him.
- 3. The President of Camp Fickes, Dabney Crump, gave a report on the status of Camp Fickes in which he:
  - Said that approximately 360 nonmember shooters used the range in 2010.
  - Clarified the range responsibilities of Camp Fickes and BCGC.
  - Discussed the preliminary results of the questionnaire that he sent out.
  - Stressed the need for gatekeepers.
  - Held a question and answer session.
- 4. Treasurer, Sam Morris, gave a brief report in which he:
  - Said that both the Camp Fickes and BCGC finances were in good shape and that he was preparing the year-end financial reports.
  - That Camp Fickes would implement electronic banking this year.
  - Asked for volunteers to assist in passing out leaflets at the January, February, March, April, June, August and September Tanner gun shows. The first gun shows being January 29 & 30.
- 5. Membership Chairman, Dan Gable, reported that:
  - He received workday lists from the June workday, clinic coaches, match sponsors, gatekeepers, gun shows, and Board of Directors that showed there were 216 workdays performed by club members in 2010.

-11 of those days were performed by club members that are non-Range Access Pass holders

-12 club members worked 1 day

-32 club members performed 2 days

-27 club members worked 3 or more days

- There are currently 167 names on the BCBC membership roster
  -4 are complimentary
  -20 are life members
  -143 are annual members
- 33 annual members have not yet paid 2010 dues and will be dropped after a final letter is mailed.
- 46 annual members were added to list in 2010.
- 6. Prior to the 2011 elections Mike Brazell said that the existing board members were willing to stay on but that volunteers were needed to fill open positions. Member Barrett Benson volunteered to serve on the Board. A vote of the membership was not taken, as there were fewer candidates than board positions to fill. Instead a motion was made, seconded and passed to accept the slate as presented.
- 7. Sam Morris made a motion that anyone serving on the 2011 BCGC BOD would be exempt from paying 2011 BCGC dues. The motion was seconded and passed.

The meeting adjourned at 9:00pm
