PRESIDENT'S CORNER

Greetings

I do have to remind everyone of some of the rules right up front. You the BCGC member are responsible for ensuring that ALL the range rules are followed and that SAFETY is the number 1 job. We cannot have people shooting out of bounds, shooting trees, rocks, wildlife or touching their guns during a cease fire. All it takes is one slip, one error in judgment and someone could get hurt. Please remind yourself and everyone around you that guns safety rules are not meant to be ignored or even bent slightly, because no one can afford to be hurt slightly. We must remain vigilant and use courtesy to remind others around us that Guns are not toys and one instance could have a lifelong impact.

I believe we had a banner year. Lots of new folks came out and joined the club, many new public shooters experienced out little bit of heaven. With that we have many more shooters now and will need much more maintenance and upkeep, wear and tear on the range will increase. We need more people to build targets, pick up trash, kill weeds, move dirt, help at clinics, cook brats, and work the gun show.

Please volunteer. Gatekeeper-- we were able to staff the gate each weekend, but we will need more gatekeepers as the public comes into shoot. We will need 3 each weekend.

Keep an eye on current federal regulations in the forest, the FS is trying to tighten up the public shooting process and in some place make it near impossible to shoot in the forest. With that, our range will see more and more use. Get involved at a grass roots level and help protect our shooting sports and shooting rights.

We need folks to help with the Strategic plan. This is our face to outside agencies-- we are judged by this, the application and our members. We have had a few folks step up and help, but this is going to be a continual process. Refining and sharpening our paper image.

We as a board have discussed many future plans, -- a new tactical range, archery, and maybe even shotguns--- Is the mad shot gunner here--???? He costs the range money each time he destroys our targets.

We are looking at co-oping with the Division of Wildlife and hosting Hunter Safety. We are planning and designing a new Pistol clinic curriculum.

We have worked with the folks from Appleseed, and we hope to broaden that partnership and become a Anchor club for them in the front range. We can get national exposure with this group and good media attention can only help

We had the road graded, a new berm installed, steps fixed, benches repaired, new benches installed, signs went up. But there is still stuff to do.

If you have a special skill or talent, let us know. We might not need that help today, but maybe in the future we could use that skill. I preach this every month in the newsletter. Volunteer. Become active and come to a board meeting.
