### BCGC AGENDA TOPICS - January 15th, 2019

#### OLD BUSINESS – Owen Maddox

- Pistol Bays are our number one priority. Decided to continue with current proposal of 12 bays. Working with a Denver Engineering firm to conduct the

“Cultural Study” to obtain approval from the Forest Service to proceed with the project

- Negotiating with Bristlecone Shooting Range for possible use of our range for them to conduct outdoor shooting classes.
- Discussion on use of shot shells with Buckshot on our ranges started but was tabled for further discussion.
- Brian Hunter: Permission for BCGC Member Tom Haynie was given to establish Ham Radio communication on our ranges.
- After discussion initiated by Deland Barr, Owen Maddox made the following Motion: To clarify a previous Motion in an earlier month, the Motion was made to establish a cut-off date for new member acceptance to the Club, whereas their annual membership would be good for the remainder of that current year and the following year. That date was established as retroactive to the BOD Monthly Meeting day (15<sup>th</sup>) of August 2018 and the same month (August) of each year following, on the BOD Monthly Meeting date.
- Motion to accept by Jim Madere; Seconded by Deland Barr. Passed unanimously Secured Long Term Permit for the Range
- Raised another \$30,000, through donations, for the Pistol Bay Project (\$106,000)
- Hosted our 37<sup>th</sup> year of NRA & CMP Competition Tournaments – Congratulations go to Pete Jend for this accomplishment
- Held our First Ladies Only Concealed Carry Course
- Re-Wrote our Range Rules
- Conducted one NRA Range Safety Officer Course
- Changed RAF back to the original Work Bond
- Public Family Rate raised to \$45/day vs \$40/day; Single rate remains at \$25/day
- Removed five Dead Trees from the Short Range
- Held three range work days
- Secured an agreement with the USFS to maintain our road beginning in the Spring of 2019
- Closed the range for three weekends due to Stage II Restrictions imposed by the County & USFS
- Obtained two vehicles to be used for Fire Fighting – One donated by members Linda & Greg Logsdon
- Received 24 Fire Extinguishers, also donated by Linda & Greg Logsdon
- Trained 22 Club Members on proper use of Fire Extinguishers
