### **OLD BUSINESS** – Owen Maddox

- Annual Membership Dues – Member Planet page – payment page will be redone to account for “work bond days”
- NRA Final Report for 2017 complete
- Purchased two Conex containers for our proposed Pistol Bay Complex for equipment storage. NRA Grant funded the purchase.
- Owen discussed the state of the club, introduced board members to the membership. Owen thanked: Owen Smith for his patronage of the club and his generous donations. Bob Philips,

Donnie Kauger – webmaster, Frank McKeon who handles new member range tours, and all other members for the work at the range.

- Dr. Deland Barr, Brian Hunter, and Sam Morris terms are up, so they are up for re-election. Asked if any other members wanted to be candidates: None. Vote was taken and all were unanimously elected.
- Owen gave following recap of 2019 achievements:
- Pistol Bay project update.
- Hosted 38<sup>th</sup> year of NRA competition
- Completed assembly of 2 firefighting vehicles.
- Dean Barr completed new SOP
- Boy Scouts completed lead mitigation.
- Completed NRA grant application.
- Rich Manzer, local chair of friends of NRA. Gives the range tremendous support, advocates NRA grants.
- Purchased two 20 foot Conex containers for the pistol bay complex. NRA Grant funded the purchase.
- Sold Owen Smith's donated stock for a \$16,000 profit
- Matches completed, 4 XTC, 6 IDPA, 8 steel challenge, 6 .22 Bench Rest, & 600 yard midrange prone.
- \$60,528 increase in treasury this last year.
- Member workdays: completed 153 workdays, total workdays 355 (included BOD at no cost). Cost to club for member workdays: \$11,175.
- 53% paid for work bond this year.
- Cost to operate the club per day: \$150, \$54,740 annual.
