BUFFALO CREEK GUN CLUB MEETING MINUTES July 16, 2002

1. The meeting was called to order at 7:19PM.
2. A motion was made, seconded and passed to approve the June minutes as presented in the Newsletter.
3. **TREASURER'S REPORT**
 - No report
4. **MEMBERSHIP REPORT**
 - A motion was made, seconded and passed to accept Vick Spencer as a new member.
 - 13 final renewal notices will be sent out this month.
 - A motion was made, seconded and passed to accept the Membership report as presented.
5. **NEWSLETTER REPORT**
 - No report
6. **CMP REPORT**
 - The club's annual CMP report was misplaced by CMP and had to be resubmitted. The order for 6 new AR-15's was delayed because the report was listed as not received. The rifle order has since been confirmed by CMP
 - A motion was made, seconded and passed to accept the CMP report as presented.
7. **CLINIC REPORT**
 - 15 shooters and 5 coaches participated in the Prone Rapid Fire Clinic on Saturday, July 6th, and 21 shooters and 4 coaches participated in the Standing Slow Fire Clinic a week later on Saturday, July 13th.
 - Special steps were taken to comply with the Forest Service's fire protection guidelines. The participants gathered outside of Bailey at the Farmers' Union and were escorted to the club as a group. Club officers also watered down the impact area prior to shooting and enforced strict parking and no-smoking rules.
 - In spite of the disruption caused by the Hayman fire and the closure of the Pike National Forest, the clinics have been very successful in several respects. The instruction has been focused, detailed and effective; participants demonstrated improved shooting performance by the end of each clinic, and, by all accounts, they enjoyed the experience. The clinics have also been profitable for the club.
 - The final clinic of this season, the Prone Slow Fire Clinic, will be held on Saturday, September 14th. John Volk will be the Master Coach.
 - A motion was made, seconded and passed to accept the Clinic report as presented.
8. **SILHOUETTE REPORT**
 - The Teddy Roosevelt Match has been rescheduled: it will be held at the Green Mill Sporting Club. Many shooters felt that they need to camp at the site of the match; overnight camping at BCGC is prohibited by the Forest Service for the time being.
 - A motion was made, seconded and passed to accept the Silhouette report as presented.
9. **HIGHPOWER REPORT**
 - The Summer Match, on Sunday, July 7th, drew 15 competitors (all apparently non-smokers).
 - The cable on target 4 is broken.
 - An after-action ammunition expenditure report form is needed for the HP Match Sponsor packet. Vince Carroll will prepare the form.
 - A motion was made, seconded and passed to accept the High Power report as presented.

 - The roof of the big target house is leaking.
 - Replacement of the target house roof is still under discussion, as regards what materials are best suited for the building and how they ought to be installed.

 - The board discussed the Range Officer's duties in detail with Darrel.

 - A motion was made, seconded and passed to accept the Range Officer's report as presented.
