- The Long Range dedication to Jim Starr was a fantastic event which was highlighted by the attendance of Polly Starr and Jim's son & daughter. Dave Sullivan's historic review of Jim's dedication to Hi-Power shooting, the Juniors program and BCGC in general was informative and emotionally moving.

- Creedmore Sports donated several gift certificates and BCGC was very generous with cash awards to the parents of the top three Juniors which will be used to help defer the expense of shooting at Camp Perry this year. Corey Vandyke's (2nd place) father, Mike, immediately donated the winnings back to the Club for the Jim Starr Memorial stone.

- A discussion centered on the subject of some members shooting beyond our 600 yard impact berm. This is not allowed. All shooting has to be done with your bullets impacting one of the designated berms. Please ensure all members and guest abide by the range rules. This subject will be emphasized with all new members and readdressed occasionally with all members.
