PRESIDENT'S CORNER

Thanks to all of the 24 members who attended the July BCGC Board of Directors Meeting.

WORK DAYS -- Starting August 16th, we have 24 Public Shooter weekend days remaining for 2015. There are 50 slots open for Gate Keeper duty. The Gun Show has 10 days remaining for 2015 and 30 slots remain open. The Gate Keeper duty has priority over all other Work Day opportunities. We are required to provide Gate Keepers during the Public Shooter season, which ends November 1st, 2015. With 239 members, on an average year, 132 of you will choose to pay the \$150 yearly Range Access Fee. That is your choice and we respect that choice. In fact, that is what provides your Club with operating capital for the year. On that same average year, 107 of you will complete two or more work days, and again, thank you, we could not operate without you. This year, 153 of you have no work days credited to your account and only 23 of you have one day credited to your account. I know some of you have already signed up for work days for the remainder of the year and for that I thank you. For all other members, please do not wait to fill the Gate Keeper and Gun Show schedules. We will not have Range Cleanup or Work Days on the schedule unless all of the Gate Keeper days are filled. Many of you may wish you had signed up early when it gets close to 2016 and you want to complete the work days but there are none available. Do the Club and yourself a big favor, sign up now for Gate Keeper duty.

ANNUAL BANQUET -- It's not too early to start thinking about and planning for our 2016 Annual Membership Meeting/Banquet. Put January 16th, 2016 on your Calendar now, so you do not schedule something else on that evening. I am expecting a record crowd this year, so once we reach the maximum occupancy allowed in the venue, no more tickets can be sold.

MEMBER PLANET -- I will soon be sending out an email asking you to join Member Planet (MP). There is no cost to you. For next year, my goal is for all of us to pay electronically for the Banquet, Annual Dues and Range Access Fees and therefore eliminate the "bottle-neck" while trying to get in the door as happened last year. I have loaded your names and email into the system. I need you to join MP and keep your information up to date when changes occur.

BCGC STEEL CHALLENGE -- We conduct two BCGC Steel Challenge Matches each month; one on the first Thursday and the second match on the third Saturday. These Matches take place on the Jim Starr Long Range. Check the marquee and "Steel Challenge Competition" (Blue Tab) on our website for details about a week prior to the event. All Club members are welcome to come out & shoot this fun event and it's only \$5 for you.

The meeting was called to order at 6:02 PM
Prior Months Meeting Minutes – No Changes. Motion to accept by Jim Madere,
Seconded by Jeff Monroe. Passed unanimously.

 - Received Tax notices.
- 3. TREASURER'S REPORT** – Sam Morris
 - Current BCGC checking account Balance: \$38,445.95

 - Current Juniors Account Balance: \$708.89
 - Current Raffle account: \$501.20
- 4. MEMBERSHIP REPORT** – Owen Maddox
 - 20 new members for 2015.

 - 3 New Candidates: Tom Stocker, David Cenedella, and Justin Sturdevant. After a brief intro, all were voted in unanimously by the Membership
- 5. NEWSLETTER REPORT** – Mike McCabe
 - Stated that he had not received any articles or pictures for Spring edition and that no Spring Newsletter would be published.
- 6. ARMORER'S REPORT** – Sam Morris
 - All Club rifles are locked in the safe, including the eight remaining .22 rifles.
 - All rifles had the bores cleaned.

 - A discussion was had regarding whether or not to reimburse Junior Shooters who participate at Camp Perry for their entry fees. Owen will look into the costs and present the information possibly for a vote.
