PRESIDENT'S CORNER

Thanks to all of the members who attended the June BOD Meeting.

BCGC TAX STATUS – The Internal Revenue Service reversed its decision and ruled in favor of BCGC becoming a 501(c)(3). We are now accepting “Tax Free” donations effective back to January 15th, 2016. More details will follow in emails to the Membership.

REQUIRED TO WEAR YOUR BCGC ID CARD – Many of us have become lackadaisical in the requirement to display your BCGC ID Card at all times while on our Permitted Range Area. Please query anyone on the property not displaying their ID Card. Report all violators who refuse to display their card to any of your Board of Directors.

ALL BULLETS ARE REQUIRED TO IMPACT THE APPROPRIATE BERM – I apologize in advance to all members who abide by all BCGC policies and range rules. However, this issue is of such importance it has to be dealt with severely. Violation of this policy could lead to BCGC not getting a renewal Permit, this coming December, to operate our Range in the Pike National Forest.

It is prohibited to set up targets on ANY of our ranges in such a manner where the bullet will impact a rail-road tie, go over the berm or skip on the ground. ALL bullets fired must impact the appropriate berm. For the first offense, violators will be issued a Letter of Warning from the Board of Directors. A second violation will result in Board action to terminate your BCGC Membership.
