BCGC AGENDA TOPICS - June 15th, 2021

OLD BUSINESS - Owen Maddox

- o Owen Maddox -- Forest Service & Pistol Bay Complex – A few weeks ago the USFS asked me to revise our Proposed Pistol Bay Complex to include everything the club may want over the next several years. I presented them a revised proposal that would take our facility from 47.33 acres to 263 acres. The original 12 Pistol Bays will now be 13 bays with one dedicated to the .22 RFBR shooting. Other proposed ranges are for Archery, Sporting Clays, a 270-degree Shooting Range and a Recreation Area. The USFS agreed to fund the cost of our NEPA Study. I also asked for an additional road, to include maintenance, to be built so we can have a

one-way entrance & one-way exit. If the NEPA Study is approved, construction could begin by the first quarter of 2022. We raised \$199,765 for the project through donations and currently have \$177,050 remaining.

o 2020 Accomplishments

- o Purchased two 20-foot Conex containers for the Pistol Bay Complex
- o \$8,219 increase in treasury for 2020
- o Cost to operate the club per day: approximately \$80/day
- o Range Fire Trucks – VP Brian Hunter built two fire-fighting vehicles and produced video on their operation
- o Front Gate Lock Updated & will be strengthened and welded soon
- o Camp Fickes Ranges were open 121 days for Public Shooters compared to our Permit requirement of 180 days. However, 109 days were closed due to US Forest Service restrictions on Fire Bans, Covid-19 and Christmas Tree cutting. Therefore, we met our minimum requirement by 12 days for 2020.
