### BUFFALO CREEK GUN CLUB MEETING MINUTES – March 13, 2001

1. The meeting was called to order at 7:20 PM.
2. A motion was made, seconded and passed to approve the February minutes.
3. **TREASURER'S REPORT**
  - The Treasurer's report showed a checking account balance of \$6025.01 and \$12,333.69 in CD's for a sum of \$18,358. 70 in total assets.
  - A motion was made, seconded and passed to donate \$100 to the Whittington Center.
  - The Range Fund and Junior Fund will remain empty for the time being.
  - A motion was made, seconded and passed to accept the Treasurer's report as presented.
4. **MEMBERSHIP REPORT**
  - A motion was made, seconded and passed to accept two new members in attendance: Dave Mayfield and Jeff Anderson. Both are experienced High Power shooters, and both have coached for BCGC clinics.
  - Copies of the By-laws and Operational Policies will be mailed to all members and posted on the website.
  - Approximately 50% of the members have renewed for 2001.
  - A motion was made, seconded and passed to accept the Membership report as presented.
5. **NEWSLETTER REPORT**
  - 152 newsletters were mailed; again, Bill Doan's was returned.
  - A motion was made, seconded and passed to accept the Newsletter report as presented.
6. **CMP REPORT**
  - Some Kimber 82's have been shipped with slash marks on stocks from careless package inspections.
  - Some of the Kimbers being shipped are NOT U.S. Govt. labeled.
  - The original cost to the government of the Kimber 82's was \$878.00 each; these are now on sale for \$600.00.
  - 10,000 Kimbers have been released for sale; 1000 have been ordered so far.
  - A motion was made, seconded and passed to accept the CMP report as presented.
7. **CLINIC REPORT**
  - No report.
8. **SILHOUETTE REPORT**
  - No report.
9. **HIGHPOWER REPORT**
  - No report.
10. **JUNIOR REPORT**
  - Jim Starr mailed out 199 match fliers for the High Power program.
  - There have been some problems arranging billeting for the Juniors at Camp Perry. Jim is working on getting this straightened out.
  - A motion was made, seconded and passed to accept the Junior report as presented.

11. **RANGE OFFICER'S REPORT**

- Despite 14-16" of snow at the main gate and some difficult going, Chris Puneski got into the club recently; the firing points were clear.
- Dan Gabel gave Mike Bogard a second completed pulley assembly for testing.
- **NOTE:** Dan presented the following list of Work Bond projects that need to be done: (1) install 5000 feet of 2-strand non-barbed wire fence w/300 posts and 50 warning signs; (2) remove trees close to buildings for fire prevention; (3) construct 5 new target carriers; (4) prefabricate 30 new target pulley assemblies and install them.
- A motion was made, seconded and passed to authorize the purchase of top quality, straight, clean lumber for making the target carriers.
- Dan will make arrangements with Vince Carroll for efficiently fabricating the pulley assemblies after the test models are approved.
- A welding outfit will be required to install the new pulley assemblies.
- A motion was made, seconded and passed to accept the Range Officer's report as presented.

12. **SMALLBORE REPORT**

- No report.

13. **OLD BUSINESS**

- Jim Starr reports that field phone are available for \$150. The board discussed the use of wireless units that are cheaper and more reliable. Communications will be addressed at the first work party.
- The .223 Sellier & Beloit ammunition functioned well in testing and was acceptably accurate for use in AR-15 clinics.
- A motion was made, seconded and passed authorize the purchase of 2000 rounds of commercial .223 ammunition for use in the AR-15 clinic in June.

14. **NEW BUSINESS**

- Dan Gabel brought up three amendments to the Operating Policies for discussion: (1) noting when the gate lock combination will be changed; (2) designating that the small target house is for practice shooting and will remain unlocked, while the large target house is for matches and will remain locked; and (3) notice on the Release of Liability form. The board discussed each.
- A motion was made, seconded and passed to accept the three amendments to the Operating Policies as discussed.
- The board discussed updating the membership package sent to new members. Dan will contact George Kruger about this.
- Richard Bowman gave the board several pages of ideas and suggestions for expanding the club's services and activities and making them more profitable. The board tabled Richard's suggestions for discussion next month.

The meeting adjourned at 8:36 PM.
