## PRESIDENT'S CORNER

Hello BCGC Members,

Thanks to all of the members who attended this month's Membership Meeting. It was packed with agenda items and we were able to discuss most of them. A few special items of interest to many of you were approved by your Board of Directors: 1) BCGC/Camp Fickes T-Shirts. A committee is working with vendors and we will ask for your pre-order input on colors & sizes very soon. 2) Another 2014 raffle was approved. If you have suggestions on a Raffle Prize and date for the raffle, let me know. 3) The Board and members in attendance voted unanimously to hold all of the remaining 2014 Membership meetings at the Indian Hills Community Center. 4) The NRA Basic Range Safety Officer course will be offered on April 19th at the Camp Fickes Range Stat House. The class filled up very quickly after posting it on our website. We will continue these courses in the future as long as there is interest.

I was at the range this week after the Membership Meeting. From Bailey on CR 68, FS 550, & FS 549, the roads were clear of ice & snow almost all the way to our gate. We have to help with every event. We need you to learn from the small group of volunteers that we currently have so you can become a Match Director next year. High Power shooting was the foundation of our club and we cannot let it go by the wayside; for inspiration on this subject, please re-read our BCGC History. - Possible 50 BMG at the range was discussed but tabled for a committee study.
- A motion to run a 2014 Raffle was presented by Owen Maddox, seconded by Sam Morris. It was approved unanimously by the Board. Date and prize to be determined later.
- A motion to buy BCGC/Camp Fickes T-Shirts was presented by Owen Maddox, seconded by Dan Bassett. It was approved unanimously by the Board.
- A motion to spend \$2,000 from the Raffle Account and \$2,000 from the BCGC Checking Account for t-Shirt purchase was made by Owen Maddox, seconded by Dan Bassett. It was approved unanimously by the Board.
- A Range Safety Officer (RSO) class will be held at the Range in the Stat House on Saturday, April 19<sup>th</sup> 2014 from 8:00AM until 5:00PM.
- Owen briefed that Tom Petersen volunteered to design and produce Glossy Leaflets for advertising Camp Fickes and BCGC. He will place these in several of the smaller retail Gun Stores, Forest Service Offices and Gun Shows.
- A motion to discontinue "Free BCGC Club Memberships" for winning a Clinic was made by Owen Maddox, seconded by Dean Barr. After discussion, the motion passed unanimously by the Board.
- Dan Bassett (for Kenny Crowley who could not make the meeting) discussed a possible proposal from Larry Davis to operate some type of shooting course on our range. The proposal was tabled for further discussion with Camp Fickes President Dabney Crump.
- Bill Westfall briefed the membership on possible projects for Eagle Scouts. The Board discussed possible signage projects on the Long Range that may be suitable for the Scouts.
- A donation for the Conifer Lobo's Wild Game Fundraiser was discussed but was deemed too costly for consideration.
- A motion to donate two Range Days and two hours of beginner pistol or long range rifle instruction for Bailey Days was made by Owen Maddox, seconded by Dean Barr. The proposal was passed unanimously by the Board.
- A motion to bestow Endowment Member Status on Jim Barkdull for his continued service and contribution to the Club was made by Owen Maddox, seconded by Dean Barr. Discussion centered on the fact that Jim personally sold over \$2,200 in tickets on the last BCGC Raffle and worked as the third Gatekeeper on more than 10 occasions. The motion passed unanimously by the Board.

The meeting adjourned at 8:23 PM.
