- Four documents and request for Permit due to USFS May 2016. Asking for 25 year permit in hope of receiving 15 to 20 year permit instead of 10 year.
- Grant Application (16CO086) for pistol bays was accepted by the NRA foundation and is being considered in the FINAL process board.
- Dean Barr is updating Educational and Training documentation.
- Dean is QC'ing our club using the IRS Form 990 & Colorado Governance principals due at beginning of April.
- Range Orientation required. Rough draft in works for checklist.
- Range rules review: Dabney is spearheading the SOP.
