OLD BUSINESS - (7:15)

- Forest Service Bond issue – Met again, Owen proposed \$25,000 letter of credit from BCGC and annual increase of \$1000. FS proposed annual increase of \$5000 per year for 5 years to bring total LOC up to \$50,000. Owen motioned to increase previous motion of \$1500 per year increase up to \$5000 per year for 5 years with the idea that Owen will propose only a \$2500 per year for 10 years increase to FS, seconded by John Williams.
- Pistol Bay Project – FS asked for revised proposal, Owen submitted revised 12 bay complex.
- NRA Grant – awarded another grant of \$4000 for pistol bay complex.
- CP&W proposal – met once, two weeks ago, helping American Bow Hunters Club. Staunton Park off 285 wants to build archery and 22 LR range. Owen proposes partnering with CP&W and let their shooters from safety course use our range for the shooting portion of their training. Idea is to ask CP&W provide us with a training site (building) on the new pistol bay complex. And possibly vault toilet.

- Deland motioned that Owen discuss the above proposals with CP&W, seconded by Brian, Passed unanimously
