Motion to accept above reports (JH), 2nd (SM) – Passed.

Old Business:

- (BH) Short Range Shed, 3 years ago approved a \$1,000.00 for new shed. But delays postponed execution, recently went to Costco, prices have increased.
 - Home Depot has a 8'x10' for \$1,200, plus base set up, total of \$2,000 total. So, need for additional \$1,000.00 w/ cushion needed.
 - Motion for additional \$1,000.00 for Short Range target Shed, 2nd (JH), Passed.
- (BH) Range Vehicles, we need a maintenance program, offer a work day credits to membership to periodically maintain (oil, antifreeze, etc.) the vehicles. Would be up to that member to create that maintenance program (SOP, etc.). The work must be done on Range (Vehicles are not licensed to drive on roads). Brian to send out email to Membership for a volunteer.
- (BH) NRA Day, Grant \$ from NRA requirements is to post a NRA Day. Similar to Open House, with various events, prizes, etc.
 - Other idea was a Range Open day, free to all w/extra Gatekeepers.
 - Advertise on websites, end of road, out by Bailey/Pine, VFW, etc.
 - Timing: During Public Season/Weekend w/o Matches. Best before School start in Early August Best. Saturday the 6th best. Will plan for next year a Open House w/Events/Food, etc.
 - Motion: To hold an Open House/Free Day August 6th in recognition of NRA Appreciation day w/Extra Gatekeepers and advertising/signs. 2nd (OM) Passed.
- (BH) Disband Committee's, Committees typically fade away. Might be best to formally close those committee's and communicate that in the minutes.
 - Election Committee Closed
 - Equipment Committee Near Complete
 - Bylaw's Committee Near Complete
 - IT Committee Just started
 - Road Committee No Update
- (BH) Provide a motion to match Lawyer fees actually paid. In previous Meetings Board approved \$1,500.00 (2 motions). Needed 2,495.00 \$1,500.00 current approved. Need 995.00.
 - Motion: We approve the additional \$995.00 require to complete bylaw budget.
 2nd (JW) Passed.
- (OM) Bylaws Next Steps:
 - Board has the red-line version for review. Currently administrative changes, few significant changes. It does have clauses about what to do with equipment, etc. in event we close business.
 - All the 'Shall' language has been changes per the legal team's recommendation. Shall now means something else, so must be replaced with Will, May, Must, etc.
 - Once Board approves (remote review, changes and final meeting to review/approve) the By Laws, the Final version will be sent out to Membership to approve soon (next Month possibly).
- (JH)Long Range Steel Add PRS/NRL Steel Club targets to Long Range along the IDPA berm.
 - Provided Steel may be donated (best if ½ AR500 Targets). Includes Tank Traps, and other shoot from barricade setups.
 - Will provide a locked job box to lock up the targets near the IDPA range.
 - Club Members availability Requirement is to be able to set up and tear down the targets to protect/secure the steel.
 - SOP Club rules not yet defined. Will set up first targets this month.
 - Motion: Members interested in building / donating PRS Steel Course, barricades and targets on long Range and a locked storage location. 2nd (OM) Passed.

 - Group has met, reviewed other non-profit examples.
 - Still working BCGC inventory (Hardware, Software, Support practices, etc.)
 - Building Plan next two months.
 - May become a member or board member to manage
 - (JH)Shot Markers SOP/Install in process

 - He is willing to share his notes on Past SOP development material, awaiting Adam's return call. Waiting.
 - May is the ETA to setup
 - SOP not defined till after initial setup
