BUFFALO CREEK GUN CLUB MEETING MINUTES May 13, 2003

1. The meeting was called to order at 7:15PM.
2. A motion was made, seconded and passed to approve the April minutes as presented in the Newsletter.
3. **TREASURER'S REPORT**
 - The club's checking account balance is \$24,132.42. \$2600 of income has been recorded since last month.
 - Jefferson County has reassessed the taxable value of club property, including a \$2400 increase in the value of the Stat House to \$16,770 and a \$5 decrease in land improvements to \$70.00.
 - A motion was made, seconded and passed to accept the Treasurer's report as presented.
4. **MEMBERSHIP REPORT**
 - Martin Prater declined membership and has been removed from the club roster.
 - 120 membership cards have been mailed out. (183 members are on the roster.)
 - A membership application was received in the mail from Bill Zollinger.
 - Mike Vanek, Jeff Stebbins, Joe McKnight and Richard Gans were present at the meeting to submit their applications.
 - A motion was made, seconded and passed to accept all four applicants present as new members.
 - A motion was made, seconded and passed to accept the Membership report as presented.
5. **NEWSLETTER REPORT**
 - 182 newsletters sent out: none returned.
 - Stan Todd's address in Texas has been corrected.
 - A motion was made, seconded and passed to accept the Newsletter report as presented.
6. **ARMORER'S REPORT**
 - The CMP Report for 2002 isn't filed yet; Kent Beach will call CMP and get authorization for digital filing.
 - \$1249.00 worth of .30 Ball was sold at the April Tanner Gun Show at .25/rnd. to members and .30/rnd. to non-members.
 - Mike Bevelhimer and Jeff Monroe broke in 5 new AR's and Kent Beach helped sight them in before the Sitting Rapid Fire Clinic.
 - Four 20 rnd. magazines are needed for the new rifles.
 - Shawn McKenna, who represents and is sponsored by Rock River, can get deals on RR uppers for \$600 each; RR National Match lowers can be purchased from an FFL dealer for \$240 each.
 - Richard Gans volunteered to check out the dealer cost for RR rifles; he is employed at Dean's Firearms.
 - Kent Beach is authorized to research AR purchase deals and decide which to order.
 - A motion was made, seconded and passed to accept the CMP report as presented.
7. **CLINIC REPORT**
 - 36 shooters, 12 coaches, 1 pit boss and 1 cook showed up at the Sitting Rapid Fire Clinic on Sat. June 10. Despite heavy snows along the foothills, weather conditions at the range were good and the clinic ran smoothly.
 - A motion was made, seconded and passed to accept the Clinic report as presented.

9. HIGHPOWER REPORT

- Labels for prize money, as well as financial and environmental report forms are ready for the Anniversary Match and Spring Match.
- Stewart Leach and Vince Carroll consulted together to create the match director's kit.
- Vince Carroll will have the championships match mailing sent out before the end of the month.
- The 600 Any/Any Match on May 4th drew 22 participants. It was a good match in spite of spring-like periods of high winds and blowing snow flurries. John Pentycufe was the Match Winner with a 583-17x performance. Special thanks go to John and to Shane Harless Sr. and Jon Coppenbarger for their help in organizing and running the match.

High Power Service Rifle Marksmanship Clinic Schedule

Buffalo Creek Gun Club will be hosting High Power rifle clinics throughout the summer of 2003. These clinics have been designed to cover all aspects of High Power Service Rifle competition shooting. The clinics will each include an informative lecture on safety, handling, and function of the AR15 rifle. At the close of the day participants will learn to field strip and clean the AR15. Each event will focus on one of the four positions used when shooting in competition, according to the following schedule:

Sat. June 14, 2003: 200 yard STANDING SLOW FIRE

Sat. July 12, 2003: 300 yard PRONE RAPID FIRE

Sat. Sept. 6, 2003: 600 yard PRONE SLOW FIRE

Buffalo Creek Gun Club will furnish "National Match Grade" AR15 rifles and ammunition for these clinics. The price for these clinics is \$45.00 each or \$150.00 for the series of four (Pre-paid), ammunition included. (Juniors \$30 each/\$100 series) If you wish to be instructed using your own service rifle, you will be allowed to do so. However, BCGC will only be able to furnish ammunition for those rifles using the .30-06 or .223 cartridge. Any other rifles will require you to furnish your own ammunition.
