3. TREASURER'S REPORT - Sam Morris

- Current BCGC account Balance: \$11,720.
- We still owe ~\$6K to Dabney.
- Club financials are available at the head table
- A motion was made by Jeff and seconded by Mike to accept the Treasurer's report as presented.

4. MEMBERSHIP REPORT – Owen Maddox

After a brief intro from each, they were voted in unanimously by the Board.

- A motion was made by Denny and seconded to accept the Membership report as presented.

5. **NEWSLETTER REPORT – Mike McCabe**

- Mike couldn't attend - his report:
 - 16 additions to distribution list
 - 5 deletions
 - 5 updates
- A motion was made by Denny and seconded by Jeff to accept the Newsletter Report as presented.

6. **ARMORER'S REPORT**

- Sam: All rifles are accounted for and STILL locked in the safe – ready for summer.
- We still need a plan for the H&Rs and Kimbers.
- A motion was made by Jeff and seconded by Barrett to accept the Armorer's Report as presented.

7. **CLINIC REPORT – Pete Jend**

- Pete couldn't attend.
- The 4/21 pistol clinic had 3 paid attendees. Sam has the proceeds.
- A motion was made by Jeff and seconded by John to accept the Clinic Report as presented.

8. **HIGH POWER REPORT – Greg Hawke**

- At the match, we had 21 shooters; 4 had range access passes, 2 were not NRA members.
- Jason Russo ran the mid-range match with 4 shooters.
- \$305 was raised, with \$155 paid out for prizes. \$150 into the BCGC account.
- A motion was made by Jeff and seconded by John to accept the Clinic Report as presented.

9. **JUNIORS REPORT – Mike Brazell**

- Two Thursdays were snowed-out. Another Thursday, there were no attendees.
- After much discussion, motion by Gavin, seconded by Jeff, and approved unanimously: The \$4081 from Raffle 1 will be split as follows:
 - \$1081 to be used as seed money for Raffle 2
 - \$1000 to the Juniors
 - \$1000 to the Club fund – to pay Dabney
 - \$1000 to range maintenance.
- Mike: We need a legal opinion on transporting weapons for use by others at clinics, etc.
- Action Item: Owen will check with the NRA counsel.
- John: We should scribe all magazines with pre-July 1 date.
- Action Item: Sam will photograph all magazines with a date stamp.
- Gavin: We're still waiting on the CMP ammunition.
- John has 6 bricks of Armscor 22lr ammunition for the Juniors.
- A motion was made by Jeff and seconded by Denny to accept the Juniors Report as presented.

10. **RANGE OFFICER'S REPORT – Denny Conlon (RO) and Jerry Fischer (Asst RO)**

- Making good progress – the 100yd range has been leveled on the right side. There will be 9 benches on the 100yd and 4 benches on the 50yd.
- We're rebuilding the benches on the 200-yd & 300-yd.
- The short range target backers are at the shed.
- Three new cement tabletops have been installed at the short range.
- Fresh targets are in the stat house.
- The roof is complete on the large target shed.
- There has been no evidence of the Mad Shotgunner.

- A motion was made by Jeff and seconded by John to accept the Range Officer's Report as presented.

11. OLD BUSINESS

- Dabney is *still* waiting on a return call from the USFS regarding possible dates from them to cut timber/sunlight our road.
- John: put Julie on the agenda for the next meeting to discuss the issuing of stock. 1000 shares will be issued.
- Owen: The Raffle account has a balance of \$5010. \$1010 expenses will come out June 1. Kyle Jacobson (a member) won the Raffle after purchasing \$200 in tickets.

12. ASSIGNMENTS

Open Issues Assigned prior to 4/2012

- The issuance of stock certificates still needs to be done.
- Mike B talked with Brian Wilson (lawyer) about re-engaging.
- John W: motion to formally task Julie Jacks, Paralegal, seconded by Jim. Motion carries unanimously.

Open Issue Assigned prior to 7/2012

- Gavin said we needed a new form for tracking AR's, the new and old 22's. Gavin is waiting to hear from Brian, our lawyer
- **No Status:** A new Lease Agreement form was created and will be routed to Board Members for review.

13. NEW BUSINESS

- Sam: received the Jeffco tax evaluation.
- Action Item: Owen will formally challenge that. We only own the buildings, not the land.
- Owen: Planning for Raffle 2:
 - We expect to issue 1000 tickets at \$10 apiece
 - We are surveying the membership regarding prizes.
 - We need to set a date, and proceed quickly in order to file with the state.
- Berm/wall: We have a design for the 25-yd wall; it goes to the engineer for a (free) review 5/22. Great job Jerry Fischer!
- John: We must determine who's responsible for sending out proof of insurance to appropriate agencies to cover matches etc (e.g. Whittington). Pete? as match director?
- Owen: The NRA has offered a free review of our insurance coverage.
- BCGC 5-year Plan: needs to be cleaned up and formalized into a Project Plan is progressing – still early planning stage. Using Google Docs.
- Insert in Newsletter a directive to always check the BCGC web-site when planning a visit, to make sure the range is accessible.
- Another lively discussion of the separation wall/berm project. It was determined that the current plan cannot be implemented for \$3500, and there is little appetite for investing additional funds from our treasury.
- Mike B: Motion to put the 25/100yd divider on hold while we re-evaluate the plan by the June Board Meeting. Seconded by Jeff. Vote passed with Owen and Sam voting nay. Owen noted that we have a verbal commitment from the NRA that we can work through December, and, if we're making progress, they will extend the time further.
- Jim M: Motion to spend appropriate \$\$ to have the NRA do a range evaluation. Seconded by Sam, passed.

- RSO Class: discussion results:
 - Sam spent ~\$1000 on materials
 - Barrett – class cost is now up to \$80
 - June 22 will be a dry run
 - Barrett will verify Bailey Library availability
 - Gavin: RSO Class Meeting notice will be emailed to all membership.

The meeting adjourned at 8:49pm.
