After more research, it seems that the legality of using Ham Radios for emergencies is questionable. Suggested that we ask FS for Radios that they will supply. Another suggestion was to get a member to get a Ham Radio License. Tom stated we could get several members together to take a test and course to get licensed. Another option thrown out was to research cost and feasibility of a landline.

- Dabney stated we have had good response to the gate keeper sign ups, Brian stated approximately 60% of available days have already been signed up for. So, sign up quickly before it's too late.
