 - CMP reports more outages of M-1 parts; it is currently very difficult to get information regarding inventories of parts or rifles.
 - A motion was speedily made, seconded and passed to accept the CMP report as presented.

9. HIGHPOWER REPORT
 - Vince Carroll has made up forms for the 2002 matches; all the match sponsors have been determined, and the materials are ready to register the matches with the NRA.

- Jim Starr is preparing a report on this year's campaign at Camp Perry.
- Jim announced that he will retire from the BCGC board. He intends to keep up work coaching kids, fund-raising, and acquiring bullets for Juniors with the help of Frank Hoffman. A new Junior Executive will be needed.
- A motion was speedily made, seconded and passed to name Jim Starr Board Member Emeritus.
- The Junior Raffle is now a BCGC club function; Jim wants kids from all state clubs to benefit, chiefly with help on expenses for Camp Perry.
- A motion was speedily made, seconded and passed supply \$700 for postage on the December raffle mailing.
- A motion was speedily made, seconded and passed to accept the Junior report as presented.

11. RANGE OFFICER'S REPORT

- Ten members were present at the September 29th workday.
- 200 yard targets were prepped; 600 yard targets still need facing.
- A workday was established for Saturday, April 27, 2002.
- A bill for the August through October garbage removal has been received; garbage had not been picked up as of 9/29.
- NOTE: 2x lumber is available for construction or firewood – stacked by the target house – take it if you can use it!
- NOTE: The use of motor oil is prohibited on the range; targets will be lubed with bearing grease.
- Frank McKeon reported on the condition of fencing and signs around the range perimeter.
- Vince Carroll will help with materials for new signs.
- A motion was made, seconded and passed to accept the Range Officer's report as presented.

12. SMALLBORE REPORT

- The Winter League is under way with good turnouts so far at both Cherry Creek and Boulder.
- A notable number of new shooters are participating this year.
- A motion was made, seconded and passed to accept the Smallbore report as presented.

13. OLD BUSINESS

- The sale of the club's M-1's was discussed.
- A motion was made, seconded and passed to dispose of the club's M-1's with the details and final disposition to be determined at the next meeting.

- Kent Beach will inventory the M-1's and make a recommendation for their disposition.
