 - A motion was made, seconded and passed to accept the Membership report as presented.
6. **NEWSLETTER REPORT**
 - Newsletters were mailed out to all members of record.
 - A motion was made, seconded and passed to accept the Newsletter report as presented.

9. **HIGH POWER REPORT**
 - The Fall Match had 17 participants.

14. **NEW BUSINESS**

- The board discussed suggestions for a membership drive, adjustments in the way membership renewals are handled, and the possibility of better coordinating the club's membership and the range's business schedules. No decisions were made, except that the gate combo will be changed each year on April 1st. Club and range schedules may be eventually adjusted accordingly.
- Richard Bowman reported on a Division of Wildlife program offering range development grants in which the government provides 75% of the funds for a range project. Richard will research this further in regard to building a new pistol range—50 yards X 50 yards. The Boy Scouts will submit a proposal to the Forest Service.
- Richard will also submit an application to the NRA for getting NRA Gold Club status.
- The Annual Meeting will again be held at the Hickory House in Parker in January.
- Dabney Crump suggested that he be the club contact for scheduling volunteer days manning the gate. He will maintain an updated list of volunteers on the website.
- Mike Brazell volunteered to serve as a board member at large.
