#### BUFFALO CREEK GUN CLUB MEETING MINUTES October 19, 2010

- 1. The monthly board meeting was called to order at 7:00pm.
- 2. A motion was made, seconded and passed to accept the September minutes as published in the Newsletter.

#### 3. MAIL CALL

- The NRA insurance renewal form was received.
- Two applications for membership were received.
- A motion was made, seconded and passed to accept the Treasurer's report as presented
- 4. **TREASURER'S REPORT**.
  - The Camp Fickes and BCGC books are in order.
  - A motion was made, seconded and passed to accept the Treasurer's report as presented
- 5. **MEMBERSHIP REPORT** 
  - A motion was made, seconded and passed to accept Dan North, Steve Giebner, Cyd Lantz, Tim Hughes, Vincent Kenney and Brian Kullman as new members.
  - No additional responses to the letter that was sent to non-dues paying members notifying them that they will be dropped from the club's membership roll were received.
  - Several work bond scenarios were discussed for possible implementation next year.
  - A motion was made, seconded and passed to accept the Membership report as presented.

#### 6. **<u>NEWSLETTER REPORT</u>**

#### 7. ARMORER'S REPORT

- The club owns nineteen AR-15's and sixteen 22 rifles. Several of the AR's need minor refurbishment.
- The need for additional secure rifle storage capacity and possible solutions were discussed.
- The BOD agreed that it would be more convenient for the Clinic Directors if the AR's were stored closer to the range. Sam Morris agreed to make the necessary arrangements.
- The firearms lease agreement has not been updated for a number of years. Kent Beach will update the lease agreement to reflect current conditions and present it to the BOD for approval.
- Kent Beach reported that the clinic brass that was sent to River Valley for processing still has not been returned and, contrary to some reports, they are still not answering the telephone.
- A motion was made, seconded and passed to accept the Armorer's report as presented.

#### 8. <u>CLINIC REPORT</u>

- In 2011 there will be 2 introductory rifle clinics (all positions at 200 yds), a third, more advanced rifle clinic, over 200, 300 and 600 yards, and a possible basic pistol clinic.
- The clinic fee schedule will be reviewed at the end of November and the 2011 fee schedule set.
- A motion was made, seconded and passed to accept the Clinic report as presented.

#### 9. <u>HIGH POWER REPORT</u>.

- The 2010 Highpower match financials will be reviewed at the end of November and the 2011 fee schedule determined.
- The possibility of adding matches in 2011 was discussed.
- A motion was made, seconded and passed to accept the High Power report as presented.

- The 2011 BOD Nominating Committee is Gavin Weekley, Ron Smith, Mike Brazell and Dabney Crump.
- The 2011 Annual Dinner will be held on Jan 15th 2011 at the Hickory House. A motion was made and passed to adjourn at 9:00pm.

#### October 2 Combat and 30 Caliber Match Results

Weather was great with 25 shooters in attendance. Tommy Christ won the .30 Cal match with an NRA match rifle (M110 type) rifle using the marksmanship skills learned at MCRD. Next was John Marx (definitely a .30 cal service rifle), another product of MCRD, and Brian Comisky. Winner of combat match (service rifle, any cal) was Andy Shepherd.High overall was Dan Bugh with a .223-scoped match rifle. This was a tough course of fire using the 20x40 inch echo silouettes at 600, 300, and 200 yds with moving targets at 200 yds. As a comparison, the US Army begins this type of match at 400 rather than 600 yds. Max possible score was 250 pts on this modified match. It's unclear who received the award plaques, and there's some question regarding Tommy's rifle. Per CMP it is not a service rifle.
