When the Fire Restrictions are lifted in 2020, open the ranges up for Public Shooters during the week using the online registration process already established. Additional Procedures for Opening to the Public: Weekends will have three Gatekeepers on duty daily, having one each on the Booth, Long Range and Short Range, when public shooters are using those facilities. All scheduled Gatekeepers will

be emailed copies of the BCGC Covid-19 Rules, Fire Vehicle Operating Instructions and revised Gatekeeper Checklist (revision will be to start both Fire Fighting Vehicle, run for a minute and turn off but leave the key in the ignition. Keys will be placed back in the lockbox at the end of the Gatekeepers shift).
