BUFFALO CREEK GUN CLUB MEETING MINUTES September 21, 2010

1. The monthly board meeting was called to order at 7:00pm.
2. A motion was made, seconded and passed to accept the July minutes as published in the Newsletter.
3. **MAIL CALL**
 - Nothing of importance was received.
4. **TREASURER'S REPORT**
 - Camp Fickes and BCGC are solvent.
 - The club's taxes were filed.
 - 213 people used the Camp Fickes range so far this year
 - A motion was made, seconded and passed to accept the Treasurer's report as presented
5. **MEMBERSHIP REPORT**
 - A motion was made, seconded and passed to accept Barry Alan, Bill Westfall and Joseph Devlin as new members.
 - Two members responded to the letter that was sent to non-dues paying members notifying them that they will be dropped from the club's membership roll.
 - 90 range passes were issued this year.
 - A motion was made, seconded and passed to accept the Membership report as presented.
6. **NEWSLETTER REPORT**
 - 107 July E- Newsletters and four paper newsletters were mailed.
 - A discussion was held concerning the mailing of complimentary copies on the newsletter to non-club members. A motion was made, seconded and passed to allow the newsletter editor to use his discretion in this matter.
 - A motion was made, seconded and passed to accept the Newsletter report as presented
7. **ARMORER'S REPORT**
 - Mike Brazell picked up the BCGC .22 rifles that were stored at BRC. Two are still out on loan. Mike will contact Mike Walton for the remaining rifles.
 - A motion was made, seconded and passed to accept the Armorer's report as presented
8. **CLINIC REPORT**
 - A discussion was held about modifying the clinics for next year to attract additional participants. One suggestion was to hold two four position clinics at the 200 yard line with a third advance across the course clinic.
 - A discussion was held concerning the possibility of adding a handgun clinic next year possibly in conjunction with Mean Streets tactical.
 - A motion was made, seconded and passed to accept the Clinic report as presented.
9. **HIGH POWER REPORT**
 - Pete Jend reported that Bill Zollinger received a complaint that the monthly match prize money is too low. A discussion followed and it was decided that raising the match fees would only reduce the participation and that our financial arrangement with Camp Fickes precludes us from contributing a larger amount of the match fees to prizes. This item was tabled for future discussion.
 - A motion was made, seconded and passed to accept the High Power report as presented.
10. **JUNIORS REPORT**
 - No report.

11. **RANGE OFFICER'S REPORT**

- A complaint was received from the Forest Service on the condition of the range access road. Mike Brazell will contact an associate about getting the road repaired
- The holes in the roof of the large target shed were repaired. These repairs are temporary as both the large target shed and pavilion roofs need to be replaced.
- Members are reminded that the firing lines are non-smoking.
- A motion was made, seconded and passed to accept the Range Officer's report as presented.

12. **OLD BUSINESS**

- The Camp Fickes stock was issued.
- Sam Morris and Dabney Crump are cleaning up the Camp Fickes paperwork with the lawyer.
- The accounting of the club's assets is continuing. Mike Brazell picked up the BCGC .22 rifles that were stored at BRC. Two are still out on loan. Mike will contact Mike Walton for the remaining rifles.
- The club's critical documents need to be scanned or digitized and stored in a central secure location. Mike Brazell will contact Mike Bevelhimer and Mike Walton for the documents in their possession. The club needs a member to volunteer as the club archivist.
- A discussion was held concerning the shortage of gatekeepers and possible solutions. No resolution of the problem was forthcoming. It was suggested that the BOD ask the membership if they know of anyone interested in a "campground host" type of position for the range.
- Volunteers are need to assist with the matches and open house the weekend of October 2 and 3.
- A motion was made, seconded and passed to provide \$300.00 to fund the open house.

13. **NEW BUSINESS**

- The Work Bond Policy needs to reviewed and revised to fit the BCGC/Camp Fickes relationship especially as it pertains to gatekeepers.
- Future Camp Fickes projects may entail a new or expanded pistol range, building a roof over the small range firing points, increasing the present small range berm height, moving the portion of the Colorado Trail adjacent to the small range, and possibly partnering with the Bureau of Prisons for range maintenance and/or improvements.
- New signs are need for the front gate before the open house.
- New signage requirements for next year need to be finalized.
- A red flag - range occupied - policy needs to be prepared.
- The board members were asked to suggest possible new meeting sites for the BOD meetings and to send their suggestions to Gavin Weekley for discussion at the next meeting.
- A motion was made, seconded and passed to allow members of the armed services who are called to active duty to retain their club membership and privileges without fees during their time of active duty.

A motion was made and passed to adjourn at 9:05pm.

Saturday Oct 2 50 Shot Rifle Combat Match - Entries are \$5 for members, \$10 non-members. 50 shot modified CBT match concurrent with .30 cal championship.

MODIFIED COMBAT EIC COURSE OF FIRE

600 yds, 10 min sight-in period with coaching

Stage 1: 600 yds sustained fire. Prone supported. 10 shots for record (magazine of 10) with a 2 minute target exposure. M9 target. At 600 yds only, all hits will be worth 5 points. Max score 50.

Stage 2: 300 yd prone rapid fire. Supported. 10 shots in 70 seconds with a magazine change. Mags loaded 5+5. (US Army time is 60 seconds) Max score 50. Normal scoring.

Stage 3: 200 yd kneeling rapid fire. 10 shots in 60 sec's. (Army spec is 50 sec). Mags loaded 5+5. Max score 50. Normal scoring.

Clear line. Shooters stand. On command load mag of 10.

Stage 4: 200 yds. Standing to kneeling or sitting. 5 shots with a 40 second exposure. Max score 25, normal scoring.

Stage 5: 200 yds. Targets will be exposed for 15 sec's; 3 shots from standing position, immediately followed by 2 shots from kneeling position. Competitors will begin this stage from the "alert" or "ready" stance. Max score 25, normal scoring.

Stage 6: 200 yds. Moving targets. Target will move at a slow walk pace up to a rapid walking pace. Targets will be numbered. Shoot only on your assigned target number. With a mag of 5 rds, fire 5 shots from standing position. Max score 25. Any hit is 5 pts!

Stage 7: 200 yds. Moving targets as above. Mag of 5 rds. 5 shots from the kneeling or sitting position. Max score 25 pts. Any hit is worth 5 pts!
Make safe-show clear. Pit change.
