# PRESIDENT'S CORNER

Thanks to all of the members who attended the September BOD Meeting.

Your club is rapidly approaching a critical date, December 31, 2016, that will determine whether we continue to operate as a Shooting Range in the Pike National Forest. Our 10-year Permit expires on that date. I have been working the US Forest Service for the past year on renewing our Permit for 20 years. Our new Permit is contingent upon a new additional requirement for us, which was recently mandated by the Department of Agriculture for the USFS, requiring our Club to obtain a \$50,000 Reclamation Bond. The Bond would be used by the USFS if our Club entered into a bankrupt status or decided to go elsewhere without reclaiming the disturbance that we have done to the forest. It is worth noting that we are the only Special Use Permit holder in the Pike National Forest that does not have a Bond, according to our Permit manager within the USFS.

We are working with national Banks and Insurance Companies in procuring the required Bond. However, there has been no interest from them (yet) in providing the service.

An alternative solution to our problem is this: We solicit voluntary investments from you, our members, to obtain the \$50,000 and place that money in a Certificate of Deposit in the name of BCGC and USFS. This has recently been approved as an alternate solution for the USFS to use instead of the posted Reclamation Bond.

Your investment would be legally documented with the provision of your return on investment set at an interest rate some number above Prime, in the 4% to 5% range, dependent upon Board of Directors approval. BCGC would strive to fully pay off your investment within three years.

I know this is a disturbing issue to deal with, especially since we have operated our range within the Pike National Forest since 1961 without a Bond requirement. However, times have changed and if we want to continue operating Buffalo Creek Gun Club and the Camp Fickes Shooting Range as we have done for the past 55 years, we have to meet the \$50,000 Bond/CD requirement.

**BCGC TAX STATUS** – The Internal Revenue Service reversed its decision and ruled in favor of BCGC becoming a 501(c)(3). We are now accepting "Tax Free" donations effective back to January 15<sup>th</sup>, 2016. More details will follow in emails to the Membership.

**2017 ANNUAL MEMBERSHIP MEETING/BANQUET** – Our Annual Membership Banquet is rapidly approaching. Mark your calendars for January 21st, 2017 now so that you are available to attend the event this year. If you are interested in working on the Auction Committee, please let me know as soon as possible. Last year we had only one volunteer to run the event and I promised her that would not happen again. So, if you or your spouse has experience in "Silent Auctions" or just want to volunteer to help out, give me a call or email.

CHECK THE BCGC SCHEDULE - As a reminder, ALWAYS check our website's "Schedule of Events" PRIOR to going to the range. Nothing is more irritating than expecting to have a fun, relaxing day at the range to only find out there is a Match scheduled on the range you intended to use. All Matches and Clinics always have priority over individual member usage.
