No report, a couple of Directors owe JH match reports.

Old Business:

- (B) FS Pistol Bay Update
 - Nathan at FS district office (local Permit Holder), introduced a new person (Jennifer DeWoody) to the range for a tour. Her title was NEPA Planner from Colorado Springs. Couple of weeks ago, Brian was present. She gathers all reports and submits to Pueblo for decision.
 - o They are working 7 other locations, the other 6 are all new sites.
 - New info from meeting is the timeframe. They told us reports are to be submitted next Summer for Decision next Fall.

- One future need from FS is the idea of Treatment (mitigation, etc.) But no requirements for near future. One of the outcomes of Treatment will be a new road into club, due to need to get heavy equipment into area...
- FYI: Looks like on the way to the Range, the FS has been marking trees, etc. for treatment last few weeks, all on north side of roads. (speculation).
- o They reiterated that we are responsible for maintaining the road.

• (SM) Long-Range Shot Markers

- Are paid for, no ETA on delivery as of yet.
- o Purchased 10 Markers, Transponders, Wiring Harness Sets, Tablets
- o Total was \$8,322 out of \$10K a lotted and includes spares.
- o SOPs have not been started yet. Will be next summer before we can start use them.

• (BH) By-Laws

- Deland did contact Lawyers, no response
- Deland has turned it back over to us to continue.
- Purpose: to clarify by-laws:
 - Special Called Meetings
 - Replacement/fill of vacancy of board members
 - Validate no risks to board or club in the By-Laws
- JW will take the request to review By-Laws with an Attorney for a review. Will come back to board with resulting conversation with Attorney.

(SE) Range Exam.

- We have agreed on the new Questions for Exam. and corrected question/answer issues.
- Have an issue with seeing new member Exam results... Will work the issue.
- o In past Membership (Owen) would contact Members on incorrect answers to review corrections. It is not currently a pass-fail exam.
- SE to make final exam decisions and implement, ie.: 3 incorrect answers will get a call back from Board Member (Sam, etc.), Limit number of exam questions, etc.

New Business:

- Mark Ippolito I am School Resource officer, for Golden U Charter Classical Academy, is a Barney Charter School, Run with a curriculum from Hillsdale College.
 - o Is a Public Charter School
 - Helping to re-write our safety policies
 - Some Teachers and Resource offices are armed
 - We leverage Faster Training, Ohio program to teach armed response in school setting
 - Qualification, involves shooting and moving.
 - Need a place to perform qualifications twice a year to keep cert.
 - o Request: Use upper range, 4 hours twice a year (noon-4pm) on shoulder season.
 - We take care of equipment, its mostly re-cert event.
 - 10 Members max.
 - Just need access to the range for a 4 hour period.
 - Preferred first day is Oct 17th, nothing is scheduled that day. Close Long-Range only.
 - Motion: To close long-range Oct 17th from noon-4pm (JW) 2nd Passed
 - Email to Donny to post on web-site "For Training".
 - Let Range Offers that day know of the closing/timing.
