### FROM THE LOADING BENCH OF STAN TODD

Hello fellow members of the Buffalo Creek Gun Club.

It is drawing close to the time of the year when a lot of us will be loading ammo for next year's shooting. I thought I would share a few details of case preparation that perhaps some of you don't know about, and, I am sure a lot of you kicked the slats out of the cradle about the time you learned them. I discussed this article with other members of the board and they gave me the green light to go forward with it with some trepidation. As in all reloading manuals, I am stating a disclaimer for any unfortunate results. The key word for reloading is finesse, finesse, finesse. Well, here goes; Primer holes where the fire from the primer enters the case is <u>pierced</u> at the factory thus leaving a ragged burr on the inside of the cartridge case, thus causing an uneven ignition of the powder charge. Don't take my word for this. Stick a bore light where you can see the inside of a cartridge case that has been fired and you will be surprised at the degree of burr.... How can you remove the burr efficiently?? Most suppliers of competitive shooter's needs such as Champion's Choice or Creedmore Sports offer a handy little chamfreing tool for a modest price. You put this tool into a <sup>1</sup>/<sub>4</sub>" drill and have two boxes for your brass, 1- full, 1- empty. Grade case, insert the chamfering tool into the case and pull the trigger on the drill. Now here comes the tricky part. You merely touch the primer hole lightly. Just enough to remove the burr and very lightly chamfre the hole. This is where the word finesse comes in. If you ram the chamfreing tool hard into the inside of the case, you will have removed too much material from the case for it to be used. I would recommend a chamfre of 0.020 - 0.030 across the flat of the chamfre. To get an idea of the dimension I am talking about, take your calipers - which you should have- and set them at 0.025 and look at the gap. This should give you a handy reference when you have deburred your case. You should have an end product of a more accuracy enhanced cartridge.

Another technique I employ is, after sizing and trimming your cartridge cases, they will be gooey from your draw oil. Which also attracts grit like a magnet, To get my cases absolutely clean after prepping the cases, I put them in the dishwasher with the required amount of detergent for an average dishwash cycle. Most dishwasher have neat little rods inside them to slide your cases on. I sometimes wonder if they had the reloader in mind when they designed the dishwasher. Run you case through a cycle, and when you pull them out you will find they are squeaky clean sans grit. Then I collect them in a Pyrex dish and put them in the oven at 200° and let them cook to get rid of any moisture in the cases. The 200° by the way, is any critical metallurgical temperature and will be fine. If you have any objections, I would like to hear about it. Just remember the word is **finesse**
